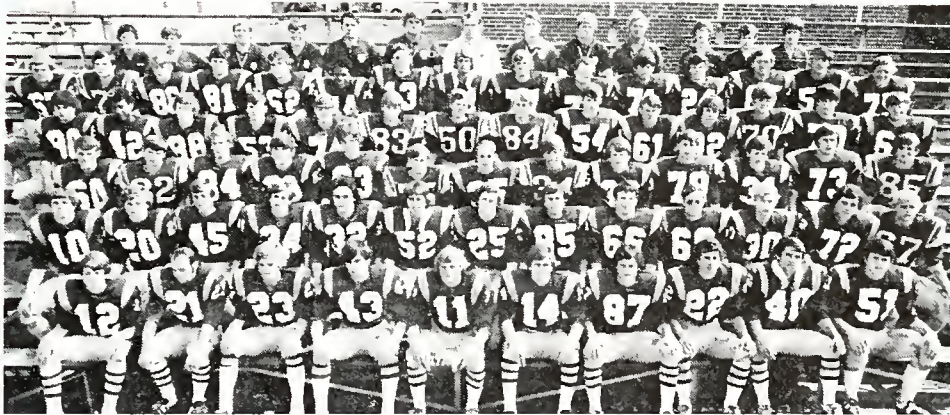

FILMS

The films listed below are in the Film Library of the University of Kentucky College of Education. The code letters "e, j, s, c, a" refer to elementary, junior high, senior high, college and adult audiences who may enjoy the particular film listed. The rental prices shown do not apply to schools which use one of the special subscription service plans offered by the Bureau of Audio-Visual Material.

Gymnastics

GYMNASTICS PART 1, j-s-c-a, 1½ reels (17 min.), \$3.00

Introduces the basic principles of gymnastics and follows the routines developed by polished performers on the parallel bars, the rope climb, and the long horse. Attention is given to the rolls, handstands, and handsprings, twists and somersaults that are basic to tumbling. (Hoefler)

GYMNASTICS, PART II, j-s-c-a, 1½ reels (17 min.), \$3.00

Introducing the gymnast to the fundamentals of free exercise routines. Stresses the importance of smooth action as well as strength, form, balance, and ability to develop the difficult routines. Demonstrates rings, side horse, and the high bar. (Hoefler)

INTERMEDIATE TUMBLING, j-s-c-a, 1 reel (11 min.), \$2.00

Demonstrates twenty stunts in handspring, balance, and somersault progressions and safety precautions are given to prevent accidents or injuries while teaching technique and form.

SIMPLE STUNTS, e-j-s-c-a, 1 reel (11 min.), \$2.00

Provides instructions in the healthful group activities that require little or no equipment. Demonstrates simple stunts for strength and skill and emphasizes safety precautions.

Injuries

TEAM PHYSICIAN, j-s-c-a, 3 reels (28 min.), color \$1.00

The message is aimed at physicians, coaches, athletes and parents. Includes five regulations which are concerned with preventing injuries as well as treating them when they occur. (KHSAA)

Baseball

BASEBALL ALL-STAR GAME OF 1965, e-j-s-c-a, 2 reels, color, \$1.00

In the 36th all-star game at the home of the Minnesota Twins in Minneapolis the National League conquered the American League by 6-5. A crowd of over 47,000 saw Willie Mays hit the first pitch of the game for a home run. (KHSAA)

BASEBALL ALL-STAR GAME OF 1966, j-s-c-a, 1½ reels, color, \$1.00

The greats of the National League battle the stars of the American League in the new 26 million dollar Busch Stadium at St. Louis. The National League won the game in the tenth inning as Tim McCarver scored on a single by Maury Wills. Close-ups of the stars are shown as they warm up for each game. (KHSAA)

BASEBALL ALL-STAR GAME OF 1967, e-j-s-c-a, 3 reels, color, \$1.00

The National and American League All-Star Game was played in the new Anaheim Stadium, home of the California Angels. The Phillies' Richie Allen homered in the first inning and Frank Robinson of Baltimore tied the score in the second. In the fifteenth inning Tony Perez of Cincinnati broke the tie and won the game for the National League by hitting a home run. (KHSAA)

BASEBALL HALL OF FAME, e-j-s-c-a, 3 reels, color, \$1.00.

This film shows the annual meeting at Cooperstown, N. Y. when new names are added to the Hall of Fame list. Numerous stars of the past return to the shrine each year at this time and are shown as their feats on the diamond are related. The history of Cooperstown and the purpose of the Hall of Fame are explained in the picture.

BATTER UP, e-j-s-c-a, 2 reels (22 Min.), color, \$1.00

Produced by National and American Leagues of Baseball. Shows the proper techniques of batting as demonstrated by hitting stars of the majors Stan Musial, Ted Williams, Mickey Mantle, Ernie Banks, Willie Mays and others.

BATTING FUNDAMENTALS, j-s-c-a, 1 reel, \$1.50

Basic skills which must be mastered before one becomes an accomplished hitter. Bat selection, stance, grip, stride, swing and follow-through are clearly demonstrated in this film by professional players.

THE BATTING STARS OF BASEBALL, s-c-a, 3 reels, \$1.00

Who are the big names among batters and what makes them good? Watch the featured hitters as shown in this film, learn the secrets of their styles and forms, and try it yourself. For clubs as well as classes.

CATCHING IN BASEBALL, e-j-s-c-a, 1 reel, \$1.50

The basic skills in catching baseball are presented in this film. How to catch a high rapid ball, a batted ball, a thrown ball, and a ground ball are shown. Stance motion and close-up photography are used to enable the viewer to follow each step or movement in each of the basic skills.

DEMOCRACY OF BASEBALL, e-j-s-c-a, 2 reels, \$1.00

The purpose of this film is for further development of young baseball players in our modern democracy and illustrates this through sports and sports competition. This film includes a brief history of baseball along with a cavalcade of past and present stars.

DOUBLE-PLAY KINGS OF BASEBALL, j-s-c-a, 2 reels. \$1.00

This film presents an analysis of the double-play in baseball. Different players from several major leagues are shown in action. Fielding, tagging, and throwing are illustrated and explained.

FIFTY YEARS OF BASEBALL, e-j-s-c-a, 3 reels, \$1.00

Facts of the immortal stars of baseball are recalled in this fifty years of memorial. Shows some famous oldtimers as their exploits are narrated and great moments of action in the lives of the more recent baseball heroes. (KHSAA)

HITTING IN BASEBALL, e-j-s-c-a, 1 reel, \$1.50

Slow motion and close-up photography are used to follow accurately and graphically the basic fundamentals of hitting in baseball. Coordination of feet, legs, hips, shoulders, arms, and head is explained. How to select a bat, how to hold it, and correct batting positions are shown.

Failure Life's Necessity

It has occurred to us nothing in our times may be more underrated than failure. We don't see failure as adding depth and richness to personal life. We don't hold failure as an antidote to the pressures of an achievement-oriented society. Instead, failure has been made to connote a permanent unfulfilled state of being.

There may be, in fact, a conspiracy against failure. In our schools, grading systems are out; pass-fail is in; and often this evolves to pass-incomplete, or pass now-pass later.

Some of us can remember with pride the day in elementary school when we moved from the reading group labeled "Dodgers," which everyone knew was the dumb group, to the "Yankees." We felt good, told Mom and Dad about it. But educators suffered pangs of conscience. "What about those who didn't advance; or worse yet, what about those who moved down from the Yankees to the Dodgers?" So schools moved to a system of heterogeneous learning groups; that is, students were no longer grouped according to ability.

The theory behind the ungraded and unranked classroom has been, if students realize failure or realize they are in slow learning environments, they become stigmatized. Then, chances of making learning progress are reduced. So allow students every opportunity to achieve and succeed, with no opportunity to be stigmatized.

Ignored in the ungraded, unranked classroom is the flip-side of the opportunity to succeed: the right to fail. Interscholastics, by preserving this right, maintains a unique place in our educational system.

There is an old adage that losing is the easy way out. It is true it is physically easier to loaf in practice and games and thereby lose. But to be the loser is not easy; it is infinitely more difficult than being the winner, especially for the person who worked diligently and sacrificed enormously in an attempt to become the winner.

Losing, or failing, makes a person pick himself up: often physically, always emotionally. It involves fighting back: sometimes against tears, usually against discouraged parents, coaches and fans and always against personal despondence. And, in reaching down to find the effort to try again, one expands the depth of his character.

In failure, one may acquire compassion for others who fail, making one a better winner in future contests. One may learn to empathize with those who appear to have failed not just in athletic or forensic competition, but in all walks of life: the family who loses its home, the man who loses his job, the mother who loses her child.

Failure is a character-building exercise of life, not a static void. To experience failure is to live, to be a part of life. Interscholastics must preserve the lessons of failure in the educational program. (National Federation)

Letter From The Commissioner

To The District Tournament Manager:

Will you please refer to your K.H.S.A.A. booklet which gives rules and regulations governing basketball tournaments. You should familiarize yourself with these rules, found on pages 31-39. Your special attention is called to the second paragraph of Tournament Rule VI-A-3, relative to the enrollment of your district coaches in the Kentucky High School Coaches Association.

The forms for your various reports are self-explanatory. The report of games should be mailed to the manager of the regional tournament not later than Monday, March 4. Send your financial report, your checked eligibility lists, and the second copy of the report of games to the Commissioner as soon after the tournament as possible. For your convenience, the following check list is given:

1. Invite member schools to your tournament AT ONCE, reminding each school to send each other member school in the district a COMPLETE preliminary list of players on or before February 1, and to send you THREE copies of a final list one week prior to the district tournament. See Rule VIII.

2. Announce the time of drawings in your letter. See Rule IX.

3. In compliance with the Federal Court Decree, all officials will be assigned by the Commissioner, composed of the Commissioner and the three assistants. In order that this may be carried out it will be necessary for each manager to send a copy of the bracket giving the date and time of each game to the Commissioner immediately after the drawing. After the Commission has made its selections, you will be notified concerning the assignments to your tournament. **It will be your responsibility to make the necessary contacts with the officials.**

In tournaments where two games are played per session, four officials will be assigned.

4. The following regulations for 1974 have been set by the Board: "The official shall receive a fee of \$30.00 per game and a transportation allowance of 10¢ per mile for all necessary travel. Only one mileage allowance will be paid if the officials travel in the same car. In the event it is necessary for the official to remain overnight at the tournament site, he shall be paid an additional \$10.00 per day for lodging and meals."

5. Tournament Rule XV says: "The Board of Control is authorized to select, standardize, and purchase trophies for all district and regional tournaments and the cost of these trophies shall be borne by the respective districts and regions." The Board has contracted with S. & M. Trophy Company, Louisville, Kentucky, to supply all of the official K.H.S.A.A. district first place and second place basketball trophies for the 1974 tournaments, each trophy complete with the Association seal and engraving. Your trophies will be shipped to you prior to March 1.

Minutes of Board Meeting

The K.H.S.A.A. Board of Control met at Stouffer's Inn, Louisville, on January 25, 1974, at 9:30 A.M. Present at the meeting was President Frank Simpson, Vice-President W. P. Wheeler, with Board members J. C. Cantrell, Howard R. Crittenden, Andrew J. Fultz, Arthur R. Hawkins, Louis Martin, James R. Williams and Roy Winchester; Commissioner J. B. Mansfield and Assistant Commissioners Tom Mills and Billy V. Wise. Mr. James McAfee represented the State Department of Education. The invocation was given by J. C. Cantrell.

Roy Winchester moved, seconded by Jack Fultz, that the reading of the minutes of the December meeting be waived since members of the Board had received copies of these minutes. The motion was carried unanimously.

Commissioner Mansfield gave a report of the Girls Basketball Committee which met in Lexington on January 16, 1974. The Committee was composed of fifteen members representing all sections of the state. Serving on the Committee were coaches, athletic directors, principals, and superintendents, namely: Jack Fultz, Olive Hill; Jean Daugherty, Louisville; Joan Mitchell, Covington; Ralph Dorsey, Horse Cave; Arthur Hawkins, Mt. Sterling; Minor Daniels, Louisville; Delores Redwine, Fairview; Millie Reule, Frankfort; Andy Hopkins, Lexington; Earl Duncan, Louisville. Barbara Call, President of the Kentucky Division of Girls and Women Sports, represented this group.

It was the recommendation of the Committee that a tournament series be sponsored by the Association in 1975 and that it be conducted as nearly as possible like the present plan now in effect for boys. The Committee requested that each school be polled and asked if a team would be entered in the tournament, if so, would a tournament in the late fall or in March be preferable.

The recommendations of the Committee were presented to the Board along with the results of the poll in so far as it was completed. The poll indicated that the tournament should be held in March. After considerable discussion the Board requested the Commissioner to draw up rules and regulations for the tournament following the suggestions of the Committee and the results of the poll. These will be presented to the Board at the March meeting for final adoption.

Following a discussion on possible proposals of the Board to the 1974 Delegate Assembly, J. C. Cantrell moved, seconded by Arthur Hawkins, that the Board sponsor a proposal that two superintendents be added to the Board of Control. That one be elected to represent Regions 1 through 8 and the other Regions 9 through 16. The motion passed unanimously.

Other proposals will be presented to all schools at the appropriate time.

Mr. Mansfield presented the case of two boys who are currently ineligible under the Transfr Rule to the Board for consideration. The first case pertained to Stephen Noe, student at Doss High School, and the other to William Jeffrey Wesley, a student at Casey County High School. Following a discussion the Board declined to take the necessary action to restore either's eligibility.

The Commissioner called the Board's attention to the fact that some changes would be necessary in a few basketball districts for 1974-75. The consolidation of schools will reduce the number of

schools in some districts to three. Each Board member was requested to study his section and make recommendation for adjustments at the next meeting. All other requests for changes will be considered at that time.

The Commissioner read a letter written by Ath. Dir. Elvis Donaldson, Bowling Green High School, at the request of several baseball coaches in that area. The request being that the Board of Control consider having double elimination in the district, regional and state baseball tournaments. After considering the suggestion, the Board felt that it would not be feasible to do so at this time because of the additional expense which would have to be borne by the schools. Also, the problem of inclement weather could create a situation whereas the tournaments could not be completed by the required time.

Roy Winchester moved, seconded by Jack Fultz, that beginning with the 1974 baseball season a game may be ended when, after five innings of a seven inning game, a team is ten or more runs behind and has completed its turn at bat. This is in keeping with Baseball Rule 4, Section 2, Article 2.

The Board approved a request from the manager of the 14th regional basketball tournament to hold the final game on Friday, March 1, 1974, instead of March 2, 1974. This change was made due to a conflict in the use of the facilities at Western Kentucky University.

Howard Crittenden moved, seconded by James Williams, that all bills of the Association for the month of December, be allowed. The motion carried unanimously.

The next meeting of the Board of Control was scheduled for Friday, March 15, 1974, at 9:30 A.M. in Louisville.

There being no further business, the meeting adjourned.

1973-74 WRESTLING

Early Season Questions

Installment II

EDITOR'S NOTE: These interpretations of the 1973-74 National Federation Wrestling Rules do not set aside nor modify any rule. They are made and published by the National Federation of State High School Associations in response to situations presented. Clifford B. Fagan, Editor, National Federation Publications

19. Situation: From a neutral position, wrestler A executes a successful duck-under and moves to a controlled standing position behind B1 near the boundary. In an effort to take B to the mat, A scissors one leg and both wrestlers contact the mat out-of-bounds.

Ruling: There has been no takedown. In order to gain a takedown from a neutral position, the wrestler must have control over his opponent, down on the mat, while the supporting points of either wrestler are inbounds.

20. Situation: From the starting position on the mat, B1 comes from underneath and gets behind A1 in a rear standing position. Afterwards, the wrestlers stumble out-of-bounds before B1 is able to control A1 down on the mat.

Ruling: B1 has gained a reversal and two points are awarded. It is not required that B1 bring his opponent to the mat in order to gain points for a

In Memoriam



William M. Falls, Sr.

William M. Falls, Sr., one of the all-time great coaches and teacher, died as a result of a car-train accident near Hopkinsville on December 13, 1973. As a coach at Hopkinsville since 1935, he was respected throughout the state and known locally for his general interest in young people as well as his coaching abilities.

Falls, a native of Davidson, North Carolina, began coaching at Attucks High School in 1935. For years Attucks was a member of the Kentucky High School Athletic League during which times he took the team to the K.H.S.A.L. State Tournament twelve times and won the championship in 1947 and 1957. The 1957 team went on to finish third in the national tournament.

Integration brought Attucks in the K.H.S.A.A. in 1957. In 1959 he took his team to the State and finished fourth.

Falls transferred to Hopkinsville High School when Attucks was discontinued where he served as assistant basketball coach. In 1966 Falls was honored at a special assembly after 29 years and his teams 500th win. On that occasion Attuck's Principal Frank Simpson, now President of the K.H.S.A.A. Board of Control, said, "He (Falls) has taught more than the game of basketball, he has taught citizenship. His teaching has gone beyond the gym." At Tuskegee Institute he lettered in track, football and basketball.

6. It is the responsibility of the tournament manager to secure adequate police protection.

7. THE BOARD OF CONTROL HAS RULED THAT NOT MORE THAN TWELVE PLAYERS MAY BE IN UNIFORM FOR ANY ONE TOURNAMENT GAME, AND THAT OTHER SQUAD MEMBERS NOT BE ALLOWED TO PARTICIPATE IN WARM-UP EXERCISES, THIS IMPLIED IN TOURNAMENT RULE XI.

8. Please ask your officials to designate the goals prior to the warm-up time for each game.

9. You will receive three copies of a final eligibility list from each school. Have one of these checked by the coach of each competing team, before his team plays, for the twelve players he will use in each game. Use only one list for checking players on each team since the other two copies may be needed by the regional and state tournament managers. Send the Commissioner all of these checked copies with your other reports. Send the two unchecked copies of eligibility lists of the winner and runner-up to the manager of your regional tournament, along with one copy of your report of games, not later than March 4.

10. It has been ruled that the 2:00 o'clock mentioned in Tournament Rule IV-B may be considered Eastern Daylight Time or 1:00 P.M. Central Daylight Time. This information concerning the starting time of the regional meeting should be given to your winner and runner-up.

11. Send Secretary Ohr of the Kentucky Coaches Association the list of district coaches to be enrolled in his organization and remittance for these, and send the Commissioner the various reports mentioned above as soon as possible.

12. Tournament Rule VI-A-3 provides that the district representative to the annual meeting may be allowed for expenses an amount not to exceed \$75.00. Since this is a maximum and not necessarily a fixed amount, the delegate should be asked to submit an estimate of the cost of his

In Memoriam



Robert P. Forsythe

Robert P. Forsythe, 56, died on October 12, 1973. Bob was born on August 20 at Benton, Kentucky. He graduated from Hughes-Kirk High School and earned his B.S. and M.A. degrees at Western. After teaching in Muhlenberg County for four years, he taught and coached in Daviess County for one year before entering the Army as a private in 1942. He was discharged in 1946 as a captain. Following six years teaching at Central City, he was elected superintendent of Greenville City Schools, then Muhlenberg County and Caldwell County before going to Dawson Springs in July 1966 in the same position.

Mr. Forsythe was an outstanding football and basketball official. He officiated in the State Basketball Tournament a number of times and referred numerous college games. The principals of the member schools in Section I elected him Director on the K.H.S.A.A. Board of Control in 1955 and re-elected him in 1959.

Mr. Forsythe was married in 1942 to Miss Clara Westerfield. In addition to Mrs. Forsythe he is survived by two sons, Captain Preston Forsythe, Fort Hood, Texas, and Noel Forsythe, Radcliff.

reversal. A reversal may be earned while in the standing position and two points are awarded B1 as soon as he goes behind A1 in a controlled situation.

Comment: The two foregoing situations are designed to illustrate the differences between a takedown and a reversal as related to a wrestler controlling his opponent in a rear standing position. A takedown may not be awarded until the aggressor has his opponent down on the mat, that is, the opponent's knee or knees must be touching the mat beyond reaction time. This is not a requirement for gaining a reversal.

21. **Situation:** A1 has his opponent in a pinning situation near the edge of the mat. As A1 turns the

torso of B1 away from the boundary, B1 moves so that the lower part of his body is outside of the wrestling area. The supporting parts of A1 remain inbounds as do the shoulders of B1.

Ruling: Wrestling shall continue as long as the shoulders of B1 are within the inbounds area. Near-fall points may be earned in this situation. If either shoulder of B1 touches the boundary line or extends outside that line, wrestling will continue.

Comment: The purpose of the present wording of the out-of-bounds rule is to accommodate this particular situation. It permits wrestling to continue so long as the supporting parts of one wrestler are inbounds. An offensive wrestler who has his opponent in a pinning situation near the boundary is not forced to break the hold, and thereby lose that advantage when his opponent goes out-of-bounds.

22. **Situation:** At the beginning of the second period, wrestler A, in the defensive position, places his knees on the mat in contact with the rear starting line and the heels of his hands on the mat ahead of the forward starting line, so that: (a) his hands are spread approximately 4 feet apart; or (b) his hands are placed so that the thumbs are together; or (c) his hands are placed so that the tips of the fingers are pointing toward each other.

Ruling: Legal positions in (a), (b) and (c) provided the defensive wrestler's elbows are not touching the mat. The requirement is that the hands be placed ahead of the forward starting line. There is no other specific placement required by rule.

23. **Situation:** Wrestler A applies a false cradle so that one of his arms is under B's shoulder blade. A tips B so that one of B's shoulders is touching the mat and the other is near the mat.

Ruling: A may be awarded points for a near-fall even though it is not possible to pin B with this false cradle. Because one of B's shoulders is in contact with the mat and the other in an angle of less than 45 degrees to the mat, regardless of the fact that one of A's arms is under that shoulder, A may gain near-fall points. The criteria for a near-fall have been met.

24. **Situation:** A1 controls B1 in a pinning situation and: (a) both shoulders of B1 are stopped within 3 inches of the mat; or (b) one shoulder of B1 is on the mat and the other within 30 degrees of the mat. The referee begins a visual hand count in both (a) and (b).

Ruling: When the referee begins the visual hand count, he has, in effect, announced that A1 has earned two points for a near-fall in (a) and (b). If an additional point is to be earned, A1 must control his opponent so that the criteria for a near-fall are met, uninterrupted, for 5 seconds. The referee is solely responsible for determining whether the criteria have been met for the required length of time.

Comment: While it is desirable the visual hand count be used, it is acknowledged there are some situations in which the referee will be unable to so signal because of the necessity for him to move quickly from one side of the wrestlers to the other, in order to be in a position to observe that the criteria are being met. Under these conditions, the referee will be unable to start the visual hand count thus indicating two points have been earned and that the offensive man is working for a three point near-fall.

25. **Situation:** At the beginning of the second

period, the referee gives wrestler A the choice of position and the choice should have been given to wrestler B. Wrestler A chooses the offensive position and shortly thereafter, pins wrestler B.

Ruling: This is not a correctable error regardless of when it was discovered. There is no provision for permitting the match to be re-started in this situation. The rules do provide for restarting the match when the wrestler is placed in the wrong position at the beginning of the third period.

26. **Situation:** In the second period of a match, A1 gasps for breath and requests a time-out which is granted. While his coach and team trainer are attending him at the side of the mat, he is given special medication to relieve his congestion. It is explained that he is asthmatic and unable to wrestle a full match without medication.

Ruling: A1 must be disqualified and the match awarded to his opponent by default. The use of special medication to relieve pre-existent conditions will cause the offending wrestler to be disqualified.

27. **Situation:** During a closely contested match, the coach of team B becomes abusive. His conduct is such that the referee requests he be removed from the gym and 1 team point deducted. Following the end of the match, the referee purposely delays signing the scorebook and waits at the official's table until the coach returns to the gym to take care of his post-meet obligations. At that point the referee deducts an additional team point.

Ruling: The referee was in error. There is no provision authorizing him to penalize a team for unsportsmanlike conduct after the meet has been completed. He was correct in deducting a team point and asking the coach to be removed for the abusive conduct during the match. There is, however, no double penalty for this infraction.

28. **Situation:** During a dual meet, a match ends with the score 6-4. B1 is the apparent winner and: (a) A1 refuses to participate in the end-of-match

procedure; or (b) A1 strikes B1 after the match is over and goes directly to his team bench.

Ruling: In (a) there will be one team point deducted from team A's score and team B will receive 3 points for the decision earned by B1. In (b), the act by A1 is flagrant and will be penalized by disqualification of A1 and one point will be deducted from team A's score for unsportsmanlike conduct. Team B will be awarded 6 points because of the disqualification of A1.

29. **Situation:** During a tournament match, the coach and manager of team A occupy the chairs reserved for such use in the restricted area. As the match, which is closely contested, progresses, the assistant coach of team moves into this area. When he notices this, the referee notifies the coach of A that only two persons may be in the restricted area. There is no movement on the part of any of the three team attendants to vacate the area as the referee returns to the center of the mat to re-start the match.

Ruling: This constitutes unsportsmanlike conduct, and the referee will deduct one team point from team A's score. There is no warning prior to this penalty. The rules clearly explain that only two attendants may be in the restricted area during tournament competition. Failure to comply with the referee's instructions constitutes unsportsmanlike conduct.

30. **Situation:** During a tournament in which mat judges are being used, those judges remain seated opposite the red and green arcs and near the edge of the mat.

Ruling: The positions described are proper when beginning the match. However, in order to best accomplish their purpose, the mat judges are authorized, in fact, encouraged to move along the mat edge in order to observe significant action. The use of mat judges is designed to minimize human error and assist the referee. It is not possible for mat judges to observe all of the action when seated in one spot. Mat judges are not authorized to be in the inbounds area during the match.

31. **Situation:** In a tournament mat judges are being used in the finals. During the 138-pound match with the wrestlers near the boundary, one mat judge observes a full nelson which cannot be observed by either the referee or the mat judge. He stands and gives the signal for an illegal hold. The referee glances at him and the other mat judge who is not standing and does not stop the match.

Ruling: The referee is in complete control of the match in progress: If only one match judge stands and the referee does not believe there is any questionable situation existing, he is not required to stop the match.

Comment: The mat judge's authority during a given match is limited. The use of mat judges is intended to assist the referee in administering the rules. The procedure for mat judges calling the referee's attention to a situation is also limited. In the foregoing, the referee should have stopped the match when one mat judge gave the signal for an illegal hold, if he were not in a position to observe such an infraction. This decision to stop the clock rests solely with the referee.

32. **Situation:** During a tournament, mat judges are being used in the championship finals. At the end of the championship match at one weight, the score is tied, and an overtime is necessitated. Is it required that two judges be assigned to observe the overtime?

Ruling: No, the mat judges will serve as overtime judges. These men will serve in the dual capacity during the overtime.

Comment: When mat judges are being used during tournament championship or consolation championship matches they will serve as judges during overtimes to assist the referee in determining superior wrestling ability, should the overtime end in a tie. These men will also assist the referee in administering the rules during the overtime. However, when mat judges are not being used and an overtime requires the use of judges, these men do not have authority to serve as mat judges. Their responsibility is limited to judging the overtime only. In this situation, they do not have authority to assist the referee in the administration of the rules.

33. **Situation:** During a tournament, team A expresses a desire to: (a) film matches using 16mm movie film; or (b) video tape. The coach of team A explains that he wishes to record the action of his wrestlers for review during the practice the following week.

Ruling: Except as authorized by individual state high school associations, filming tournament matches is prohibited in both (a) and (b). In the situation described, the state high school associations would probably authorize such filming because it is not to be used for coaching purposes during the tournament in progress.

Shows four of the leading pitchers in action. Types of pitches and methods of practice are portrayed.

PLAY BALL, SON, j-s, 1½ reels, \$2.50

Joe Cronin introduces this film showing a group of fourteen-year-old boys who are experts in baseball. Correct methods of hitting, catching, and throwing are demonstrated in natural and slow-motion. Based on book by Bert V. Dunne.

THROWING IN BASEBALL, e-j-s-c-a, 1 reel, \$1.50

Slow motion, close-up and stop photography are used in presenting the basic fundamentals of throwing in baseball. Instructions are given for the overthrows, three-quarter side, side, and under-

hand throws. Coordination of foot and arm motion is stressed, as well as coordination of the body as a whole.

TOUCHING ALL BASES, j-s-c-a, 4 reels, \$1.00

This film is intended to teach youngsters baseball by showing various American League stars playing their positions. It is also intended to give fans as a whole a better understanding and knowledge of the national pastime. The film shows Father Flanagan and his Boys Town team, the Hall of Fame Ceremonies in Cooperstown, N. Y., and scenes from night baseball games.

WORLD SERIES OF 1954, e-j-s-c-a, 3 reels, \$1.00

Highlights of the game between the Cleveland Indians and the New York Giants are shown in this film. The Giants, sparked by the sensational hitting of Rhodes, defeated the Indians in four straight games. The Indians had set a record for the number of games won in winning the American League pennant.

WORLD SERIES OF 1961, e-j-s-c-a, 4 reels, (44 Min.), color, \$1.00

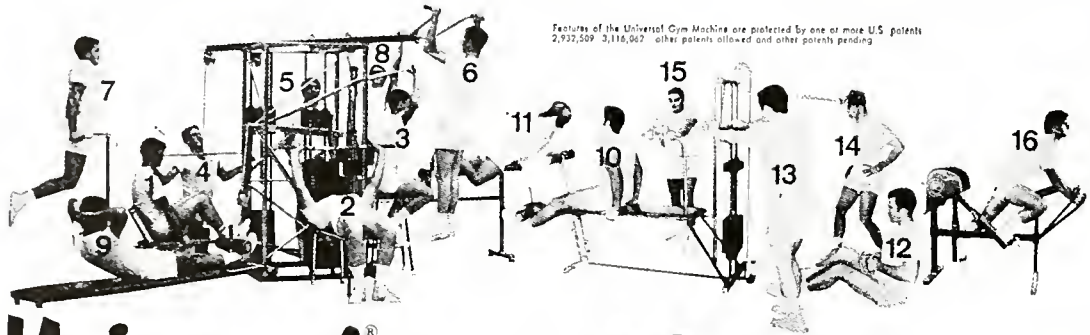
