Dear Principal:

For the past several years the Board of Control has provided catastrophe injury insurance for all high school athletes. The policy was extended to include all registered officials for the coming year. At the meeting on March 21, 1975, the Board accepted a plan to be underwritten by the Security Life and Accident Company for 1975-76.

Briefly stated, the K.H.S.A.A. catastrophe plan contains the following provisions:

1. \$1,000.00 deductible clause;
2. Up to \$25,000.00 in medical benefits per injury (after the deductible has been satisfied and after the benefits from all other insurance has been considered);
3. A student engaging in, practicing for, or traveling to or from, all activities under the jurisdiction of the K.H.S.A.A. and the direct supervision of a school employee;
4. All registered officials of the K.H.S.A.A., while officiating, or traveling to or from the game they are to officiate;
5. Coverage for medical expense incurred within two years following the date of injury;
6. The deductible is eliminated for injuries sustained during a state series of tournaments or meets.

Security Life was selected because of the competitive cost for the coverage, and their national reputation for administering athletic insurance programs. Newly Elected Board Members

Prin. Denvil Barriger of Bowling Green High School and Prin. Gene Sell have been elected from Sections 2 and 5 respectively to the Board of Control for a four year period beginning July 1, 1975.

Denvil Barriger graduated from Scottsville High School and Lindsay-Wilson College and played on the basketball teams. He earned a B.S., M.A. and Rank I degrees from Western Kentucky University. In 1950 he started a thirteen year coaching career that took him to Hart Memorial, Bowling Green and Tell City.

Denvil was principal at North Warren High School, Director of Pupil Personnel for Bowling Green City Schools prior to assuming the present position three years ago. He has been a member of the Lions Club for twelve years, a member of the Bowling Green Drug Abuse Program and the Model Citrus Board. He married Juanita Centers of Scottsville. Their son, Steve, is a graduate of Western and is assistant football and basketball coach at Anderson County High School. Daughter, Kathy, is a student at Western. There is one grandchild, Tamara Barriger. The Barrigers are members of the Glendale Baptist Church.

Gene Sell was born in Morgantown, West Virginia, on May 8, 1936. In 1954 he graduated from Fort Lauderdale High School in Florida. He served four years in the U. S. Air Force prior to enrolling at Cumberland College where he graduated in 1962. Gene earned his Master's Degree from Xavier University in 1965 and a Rank I there in 1970.

Gene was a teacher in the Silver Grove Schools for six years, at Princeton High School for three years and has been principal at Newport for six years. He is a part-time instructor at Northern Kentucky College, a past president of the Northern Kentucky Athletic Conference, past secretary-treasurer of the Northern Kentucky Association of Secondary School Principals, and is presently serving as chairman of the Ninth Region Policy Committee for officials assignments.

Gene is married to Gayle Ann Smith and they have two children, Kevin Gene, 10, and Jodi Lee, 6.

Minutes of Annual Meeting

The fifty-eighth annual meeting of the Kentucky High School Athletic Association Delegate Assembly was held at the Brown Education Building, Louisville, on Thursday afternoon, April 17, 1975.

President W. P. Wheeler called the meeting to order at 2:00 P.M. and asked Assistant Commissioner Tom Mills to call the roll. Sixty-one regular elected delegates or alternates answered the roll call.

Commissioner Mansfield then gave a report on the activities of the Association during the 1974-75 school year. Mr. Ernest Trosper moved, seconded by James A. Pursiful, that the Commissioners report be accepted. The motion carried. (The Commissioners report is printed elsewhere in this issue of the ATHLETE).

President Wheeler introduced to the Assembly Denvil Barriger, recently elected to membership on the Board of Control from Section 2 and Gene Sell who was elected to represent Section 5. Their terms are to begin on July 1, 1975.

President Wheeler stated that consideration of proposals was the next order of business. Denzil Halbert moved, seconded by Joe Ohr, that Proposal I, providing that Constitution Article IV, Section 2, Item a, be amended to read "They shall be a full-time certified employee of a Board of Education in the region they are to represent and must remain in a similar capacity in that region during their tenure of office," be adopted. The motion failed to receive the necessary two thirds vote for passage.

Denzil Ramsey moved the adoption of Proposal II. Richard Hughes seconded the motion. Proposal II states that "A student who has represented a member school as a first team player in football or basketball shall not compete in an all-star or post-season game. The penalty for violation shall be loss of eligibility in all sports for the remainder of the school year. (This would apply to students that have exhausted their eligibility in these sports.)"

A student who has been a first team player in football or basketball and has eligibility remaining in these sports shall not take part in an all-star or post-season game at any time. The penalty is loss of eligibility for one year. The motion carried.

Jimmy Wiggins moved, seconded by Arnold Oaken, that Proposal III be adopted. Proposal III states that "the football season begins four weeks prior to the opening day of school and ends with the finals of the state playoffs. Practice, contests or clinics for football shall be held only between dates set for football and no other organized practice, contests or clinics shall be permitted."

Following a discussion of Proposal III, Arnold Oaken made a motion to amend so that the part of the proposal pertaining to clinics would not take effect until 1976. Thomas W. Johnson sec-

Attention, Officials!

The registration period for K.H.S.A.A. officials is and has been for several years the same as the Association fiscal year, namely July-June. Advance applications for registration in football and basketball are not now being accepted. Previously registered officials in these sports will receive their renewal application cards at some time during the summer months after the new National Federation publications have been received in the State Office. Previously registered officials should not send in their renewal fees until they receive these cards.

Minutes of Board Meeting

The Board of Control of the Kentucky High School Athletic Association met at Stouffer's Inn, Louisville, on Thursday morning, April 17, 1975. The meeting was called to order by President W. P. Wheeler at 9:00 A.M., with Board members Louie Martin, Eldon Davidson, Jack Fultz, Arthur Hawkins, Cecil Reid, George Sauer, Frank Simpson and Ray Story; Commissioner J. B. Mansfield and Assistant Commissioners Tom Mills, Billy V. Wise and Louis Stout present. Mr. Conley Manning was present representing the State Department of Education. The invocation was given by Arthur Hawkins.

Frank Simpson moved, seconded by Arthur Hawkins, that the reading of the minutes of the previous meeting be waived since the members of the Board had received copies of these minutes in the mail. The motion carried unanimously.

Assistant Commissioner Tom Mills reported a decrease in attendance at the 1975 Boys' State Tournament. He reported the attendance at approximately 111,000 as compared to 124,000 for the 1974 tournament. The ticket sales for 1975 was approximately \$287,000.00. The total ticket sales for 1974 was \$286,142.00. The estimated tournament expense is approximately \$87,000.00.

Total paid attendance at the Girls' State

Tournament held on the campus of Eastern Kentucky University was 18,270 with gate receipts of \$44,384.00. The estimated expense is approximately \$22,000.00. A complete record of all receipts and disbursements for both the Boys and Girls Tournaments will appear in the annual audit. Louie Martin moved, seconded by Jack Fultz that the State Tournament report be accepted as presented. The vote carried unanimously.

Mr. Mansfield then reported to the Board that Maysville High School had been suspended in boys' basketball until January 1, 1976. He explained that the suspension was imposed following an incident which took place during and after the Fleming County High School and Maysville High School boys basketball game played on March 5, 1975. Letters were presented from District Tournament Manager, John H. Branson, Fleming County Principal Fairce O. Woods and Mr. Elza Whalen, Jr., Principal of Maysville High School, explaining their version of the incident.

Mr. Mansfield stated that Mr. Whalen was present and wished to appeal the suspension. President Wheeler welcomed Mr. Whalen, Superintendent Robert L. Biddle, Coach Lyle Dunbar, Assistant Coach Henry Boone and Glenn Roberson the Director of Pupil Personnel at Maysville High School. Each visitor was given the opportunity to express his views and answer questions from the Board members. Following their presentation Mr. Whalen requested that the Board rescind the decision of Commissioner Mansfield or, if they upheld the suspension, shorten the length of time to permit them to host the annual Christmas Tournament. Mr. Wheeler thanked the group for appearing before the Board and assured them consideration would be given their request and they would be informed of the final decision. The group thanked the Board for their time and departed.

Following considerable discussion, George Sauer moved, seconded by Arthur Hawkins, that the suspension of Maysville High School be upheld until January 1, 1976. All members present voted aye. The Commissioner asked if the Board would re-consider and permit Maysville to play in the Christmas Tournament. The request was denied.

Commissioner Mansfield reported that a disagreement over the distribution of tournament funds in District 52 was the next item for consideration. Mr. Dillard Prater, Principal of Cumberland High School, came before the Board representing Cumberland, Lynch and Cawood High School. He stated that these schools objected to the distribution of funds since it was not in keeping with the wishes of the majority of the schools in the 52nd District as voted upon in the District Tournament Meeting of February 15, 1975. He stated that decisions reached at an earlier meeting (held at Evarts High School on January 23, 1975, with two principals and three coaches present) should not be binding since a local agreement had been reached years earlier and reaffirmed in February, 1974, that the tournament site would be at Cawood High School until equal or better facilities were available in the district. Following his presentation and after answering several questions from members of the Board, Mr. Prater thanked the Board for their consideration and departed.

The Board then heard comments from Mr. E. R. Gray of Evarts High School. Mr. Gray stated that the decisions reached at the January 23rd

meeting should be binding since it was an officially called meeting and since all schools were represented by their principal or an appointed representative. He stated further that the vote was unanimous for the tournament site to be at Harlan High School, and Harlan was to receive 25% of gross receipts for hosting the tournament.

Mr. Tom Ward, Principal of Harlan High School and Manager of the 52nd District Tournament explained to the Board that Harlan High School had not requested the tournament but following the unanimous vote of the representatives at the January 23rd meeting he accepted the tournament and proceeded with making the proper arrangements. He stated that it was too late to make changes when the representatives took a new vote on February 15th to move the site to Cawood High School; therefore, he managed the tournament based on decisions reached at the January 23rd meeting.

Following the departure of Mr. Ward and a discussion of the facts as presented, Eldon Davidson moved, seconded by Jack Fultz, that since the coaches were official representative of the principals at the January 23rd meeting of the 52nd District officials, the decisions reached at this meeting shall be binding to all schools involved, and further, in the future, accurate written minutes be kept at all official meetings. All members voted aye.

At the request of Prin. Ray McCann a letter was presented asking the Board to restore the eligibility of James Harkins who had made himself ineligible for spring sports by participating as a substitute in a tournament run by the Federal Youth Center at Ashland after the season. The letter stated that James Harkins was unaware of any wrong doing and was not trying to defy the Association's regulation. Cecil Reid moved, seconded by Louie Martin, that James Harkins eligibility be restored by the Board by authority given it in the K.H.S.A.A. Constitution Article IV, Section 3, Item d-7. The motion carried unanimously.

Tom Mills presented the eligibility case of Ricky Spurlock, a student at Berea High School, who is ineligible under By-Law 6, Section 1, Transfer. Ray Story moved, seconded by Eldon Davidson, that the eligibility of this student be restored. All members voted aye.

W. P. Wheeler and Louie Martin were named delegate and alternate, respectively, to the forthcoming annual meeting of the National Federation.

The date for the next meeting of the Board of Control was scheduled for Friday, May 23, 1975, at 9:30 A.M., in Bowling Green.

Jack Fultz moved, seconded by George Sauer, that all bills of the Association beginning March 1, 1975, and ending March 31, 1975, be allowed. The motion was carried unanimously.

There being no further business, the meeting adjourned.

Hall and Fran Curci, basketball and football coaches at the University of Kentucky will speak to the two groups. All meetings will be held in Colonial Hall of the Campbell House.

A buffet luncheon follows the clinic, beginning at 11:15 a.m. It will conclude in time for travel to Commonwealth Stadium and the East-West All-Star football game.

Tom Stapleton of Middlesboro High School will coach the East football team, assisted by Fred Mariani of Beechwood. Owensboro's Gerald Poynter will direct the West football team with John Hina of Murray as his assistant. The East basketball squad will be coached by Al Prewitt of Lexington Henry Clay and the West will be coached by Bob Hoggard of Christian County.

Stapleton was named Coach of the Year in football and Prewitt received the same honor in basketball during the Association's annual meeting in Louisville April 17.

The Association will have help this year on its promotional efforts for the All-Star games. The Lexington Jaycees are handling all promotion and advance ticket sales and sale of advertising in the Games Program. The group has outlined an ambitious program designed to create statewide interest in the Games and insure excellent fan support.

Tickets for each of the Games are \$2.00 for adults and \$1.00 for children under twelve.

REMEMBER! The clinic August 2 is FREE to members of the Association. Information on reservations will be sent to all members at a later date.

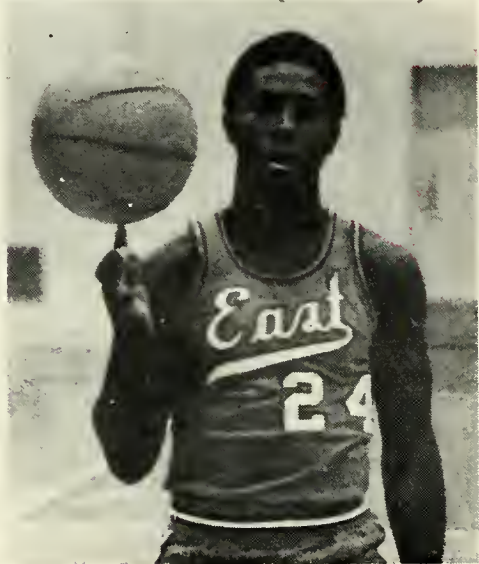
TED SANFORD AWARDS

The Athletic Budget in Perspective

HIGHER COSTS AND TIRED TAXPAYERS may mean trouble for interscholastic athletics in coming years. Inflation may require bond referenda with increasing frequency, and overburdened taxpayers may defeat them with increasing regularity.

PROOF OF THESE TRENDS is available coast to coast, in large cities and small. The board of education in San Francisco, California voted in February to halt athletic programs immediately in the city's public schools in order to save \$200,000 as part of a \$4,000,000 budget cut. Voters in Springfield, Illinois have defeated two referenda, causing the school superintendent there to recommend elimination of all extracurricular activities, including athletics, as a cost-saving measure.

THE TYPICAL ARGUMENT for elimination of interscholastic athletics is the great expense which benefits only some students in a program which is not essential to the educational process. The argument is based on three misconceptions.

FIRST, the interscholastic athletic program, when viewed with the proper perspective, is not expensive; it might even be considered a bargain. Only 69¢ of every \$100 budgeted for public education in Madison, Wisconsin, goes to interscholastic athletics—only .69 of 1 percent of the total school budget. Coaching salaries in all communities are a mere pittance for work the men and women do. The many formulae which operate to determine coaching stipends generally translate to only \$2 or \$3 an hour. Some people coach for less; and some coach without pay.

SECOND, the interscholastic athletic program long ago stopped being beneficial to only

few students. Schools, which typically offered two or three sports in the 1940's now sponsor nine or ten sports for boys and nearly as many for girls. At the same time, the depth of many sports programs has increased to include sophomore and junior varsity teams in addition to varsity squads. And those who would maintain athletics involves only the participants have not spent an evening recently at a high school basketball game or wrestling meet and watched hundreds of students and parents go nuts with excitement during a hotly contested event.

THIRD, the interscholastic program is as essential to the educational process of many young people as any other part of the curriculum. Some students can be reached best or perhaps only through mathematics, some through music, and some through football or gymnastics. Some students will mature and establish character during a disciplined study of biology, others through dedication to baseball or track. We have seen these things happen.

MOREOVER, the athletic program is a cohesive force in many communities. It stimulates interest in school activities by non-participating students and townspeople. An athletic event often provides the forum where the community becomes aware of other school activities and may be moved to support them. The people who support athletics tend to support the whole school program and are willing to pay for it. According to Gene Calhoun, President of the Madison, Wisconsin Board of Education, "If you lost athletics, you would lose one of the best supportive pillars. You would lose people who support the whole budget."

WE AGREE and we urge athletic administrators to present this perspective of the athletic program and the athletic budget.

1974-75 Annual Report

(Presented to Delegate Assembly)

Three hundred fifteen schools joined the Association for the 1974-75 school year. Twelve of these schools enroll girls only and seven have only boys. In 1973-74 there were 329 schools, in 1972-73 there were 334 and 344 in 1971-72.

There were 201 schools involved in football. The Classes A and AA championship games were played at Eastern Kentucky University with approximately 3,984 in attendance and gross receipts of \$9,429.00. The Class AAA final was played at the Kentucky Fair and Exposition Center with 4,200 in attendance for gross receipts of \$28,884.50. Interest and attendance at the regional and semi-final games continues to increase resulting in greater revenue for the schools involved. It is hoped there will be added interest this fall with classification changes and another class.

In Cross Country 146 teams entered the twenty regional meets. There were eight regions in Class A and AA, with four in Class AAA. The expenses incurred in sponsoring this sport were \$5,086.09. All state championship meets were held at Seneca Park in Louisville. The Board of Control proposes to sponsor Girls' Cross Country this fall.

The wrestling program is going forward at a rapid pace. There were 65 schools in the eight regions with the winner and runner-up in each weight class advancing to the finals. The championship tournament was held at Atherton High School.

In Classes AAA and AA Swimming, 45 girls' teams and 44 boys' teams competed for the championships. They were held at the Plantation Club in Louisville on February 21-22 and Eastern Kentucky University on April 4-5 respectively. Receipts from the two meets totaled \$1,400.00 with expenses of \$3,243.98.

There was 16 schools with boys' gymnastic teams and 29 with girls. One regional was held for the girls but there was not a sufficient number of boys' teams to justify a regional. The state meets were at Marion County High School on February 22. The receipts were \$452.70 and the expenses were \$2,434.33.

The gross receipts from the boys' and girls' district basketball tournaments were \$432,585.68 while the regional tournaments took in \$347,672.35 for a total of \$780,258.03. The approximate amount realized by host schools as profit from concessions amounted to \$94,000.00. Attendance at the Boys' State Tournament was approximately 111,000 as compared to 124,525 for last year. The gross receipts this year for the tournament was about \$295,000.00. A complete audit will appear in the August issue of the "Athlete."

Attendance at the Girls' State Basketball Tournament was 22,917. The gross receipts amounted to \$44,384.00 with expenditures of approximately \$22,000.00. The expense of the tournament was a minimum due to the cooperation of the people at Eastern Kentucky University in providing reasonable meals and lodging for the players and cheerleaders. A complete report will appear in the audit.

In the other sports that are to follow, 272 baseball teams will compete in 59 districts and

eight regions; 203 girls' track and 234 boys' teams will compete in twenty regions each; 93 girls' golf teams and 189 boys' teams will play in nineteen regions; 132 girls' tennis teams and 134 boys' teams will play in sixteen regions. State championship meets will be held in baseball at Morehead University; the Class AAA track in Louisville and the Class A and AA at Western; the girls' golf at Shelbyville; the boys' golf at Fort Knox; the tennis at the Tennis Center in Louisville.

Registering with the Officials' Division of the Association were 1,524 basketball officials, 736 football, 514 baseball at the present time and 58 wrestling. Assistant Commissioner Billy V. Wise conducted 16 clinics in basketball and 12 in football for officials and coaches. Assistant Commissioner Louis Stout conducted 11 clinics for baseball umpires and coaches. Two hundred one officials took the National Federation examination for the advanced ratings in football with 101 becoming "Approved" and 24 "Certified." In basketball 273 took the test and 150 became "Approved" and 70 "Certified." In 1974 eighty took the baseball test with 48 being "Approved" and 15 "Certified."

The Board of Control, the Assistant Commissioners and I are grateful for the cooperation the superintendents, principals, athletic directors and coaches have given us in running the program for the Association.

THOMAS JEFFERSON RIFLE TEAM WINS

The Thomas Jefferson High School Rifle Team won the 14th State Rifle Championship on April 26, 1975, with the team score of 1422. Joel Erwin of Greenup County High School won individual honors with 290 points.

Twelve teams competed in the tournament, which was held at the Seneca High School. Richard A. Conrad of the Seneca High School managed the tournament. Greenup County High School was second in scoring with 1382, and Fern Creek High School was third with 1382. Team and individual scores were as follows:

Mr. Wheeler then stated that a vote on proposals IX and X would not be necessary since Proposals III through VIII were not passed, thereby making them void.

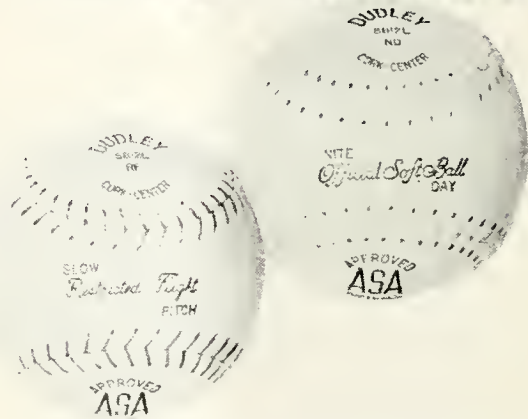
