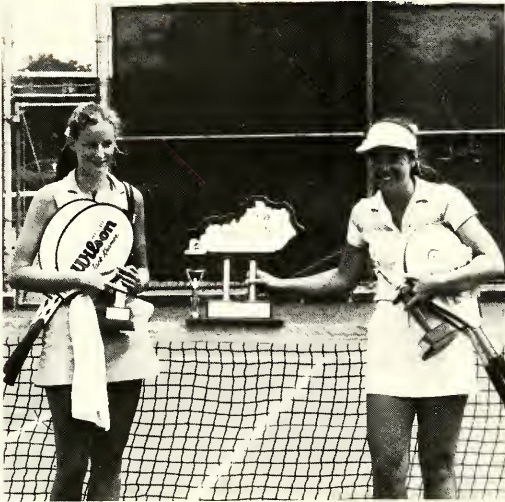

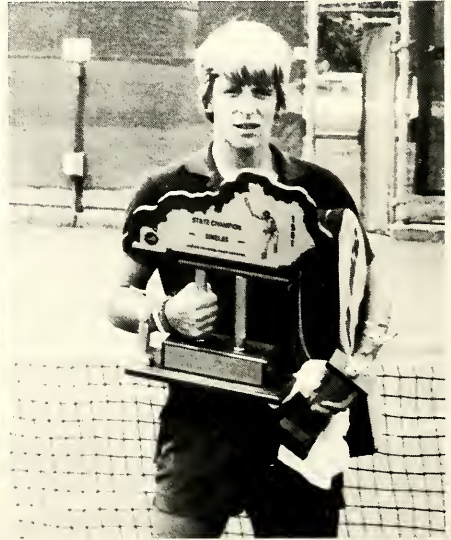
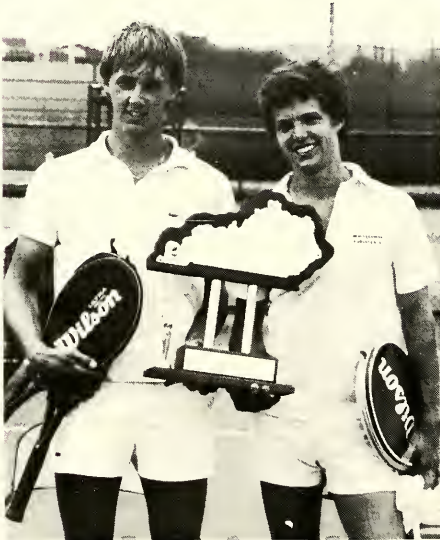

**J.D. Minnehan, Principal of Oldham County High School, Buckner, was elected President of the Board of Control at the summer meeting of the directors held on July 24, 1981. Fairce O. Woods, Principal of Fleming County High School, was named Board Vice-President.**

J.D. Minnehan is a native of Ashland, Kentucky, and has earned degrees of A.B., M.A. and Rank I at the University of Southern Mississippi, the University of Tennessee and Western Kentucky University respectively.

Mr. Minnehan's first five years in education were in the capacity of English teacher, assistant football coach and head baseball coach at Bardstown High School. He then served as Assistant Principal at Bullitt Central High School for three years and Principal of the Oldham County Middle School for one year before assuming the principalship of Oldham County High School seven years ago.

Mr. Minnehan and his wife, Judy, have a five year old son, Jason. Mrs. Minnehan is Director of Instruction for the Oldham County School District.

Fairce O. Woods was born in Floyd County, attended Garrett High School and earned an A.B. Degree at Kentucky Wesleyan College. In his senior year, 1949, he was chosen Who's Who in American Colleges and Universities and received Honorable mention on the All American Basketball team. After graduation he accepted a job teaching and coaching at Deming High School in Mt. Olivet for two years. After two years, 1952-54, in the service, he assumed the same position at Breathitt High School where he remained until 1967.

After receiving an M.A. Degree at Morehead State University in 1960, Mr. Woods served as Principal of Powell County High School from 1967 to 1971 before moving to his present position at Flemingsburg. In 1974 he received a Rank I certificate in Education from Eastern Kentucky University. He has served as teacher, coach and principal for thirty years.

**WHY A NATIONAL HIGH SCHOOL  
ACTIVITIES WEEK?**

The NEED for public awareness and support of high school activities programs is acute and each year illustrations of the lack of support or awareness of the values and needs of high school programs appear. Usually, where there is a strain on the public educational dollar, high school activity programs are the first to be reduced or eliminated. Receiving national notice is the lack of funding for activity programs in cities such as Boston, New York and Los Angeles, and the reduction of tax dollars through public mandate in Massachusetts (Proposition 2½) and California (Proposition 12). These examples of national note are only the tip of the iceberg in that in all sections of the United States demands for the educational dollar are becoming greater and the resultant strain on activity program funding increases. For instance, some school districts have eliminated the funding for athletic and activity programs altogether; in some locations students are required to pay a fee in order to participate, and there are examples of cutbacks in varying degrees in all 50 states and in all sizes of communities and schools. In many areas student and parental concern for participation in high school activities as well as the values which the students and parents receive therefrom is lacking.

As to the VALUES of activity programs, there are several very vivid, documented examples: (1) National surveys reveal that students participating in high school activities are more likely to have higher academic averages and far better attendance records; (2) of the students who drop out of high schools, ninety-four percent have not been involved in any school activities such as athletics, music, speech, student government, etc.; (3) the best predictor (according to ACT and SAT studies) of success in later life is previous participation in high school activity programs—not high school or college grade point average, test score or rank-in-class; (4) generally, participation in activity programs teaches values that make children happier and better citizens, builds strong minds and bodies, emphasizes that competition is not evil (but an American way of life), and that race, color, sex and economic status are not obstacles for participation, and finally, instills poise and confidence; (5) nationally, over one-half of the high school student population participates in high school activity programs for approximately one percent of the total school budget, **obviously** the best value in public education today.

Truly, high school activities are, in fact, "The Other Half of Education." With such values for such a minimum investment, it is important that this "other half of education" is needed and therefore public, parental and student support is a necessity. Thus, the reason for "National High School Activities Week".

The regional tournaments will be held during the week of October 19, and the State Tournament is scheduled for October 29-31, at the University of Kentucky, Lexington. ## VOLLEYBALL COMMITTEE MEETING MINUTES

The 1981-82 Volleyball Committee met on Tuesday, August 4, 1981, at the K.H.S.A.A. office in Lexington. Assistant Commissioner Brigid DeVries called the meeting to order at 1:00 P.M. Committee members present were: Bunny Daugherty, Ann Karrick, Margi McKenna, Sally Meng, Joan Mitchell, Liz Sadler, Susie Sigler and Donna Wolfe.

Brigid DeVries reported to the Committee that according to the information received on the blue forms from our member schools, there will not be a markable increase in volleyball participating schools.

The Committee members reviewed the 1980-81 regional and state tournament information sheet and made a few changes for this year. It was recommended to delete the requirement for the K.H.S.A.A. Certificate of Eligibility to be submitted to the K.H.S.A.A. office as an annual participation list is sent by each school to the K.H.S.A.A. office and the Committee members feel like this is sufficient. However, because the requirement is in the current Constitution and By-Laws the Certificate of Eligibility will have to be used for the 1981-82 Volleyball Tournament.

The Committee members agreed that an "Information Sheet for State Tournament Program" form be sent to each team participating in the regional tournament and it be attached to the 5" x 7" black and white picture (with names reading left to right). This information shall be turned in to the K.H.S.A.A. office no later than October 12, 1981.

A discussion was held regarding schools sharing the profit or loss of the regional tournaments.

There was a lengthy discussion on making attendance at the meeting before the regional tournaments mandatory. No final decision regarding this issue was made.

The 1981-82 regional volleyball tournaments are scheduled for October 23-24, and the state for October 29-31 at the University of Kentucky Memorial Coliseum, Lexington.

It was suggested by the Committee that a flyer be included in the packet sent to the schools to encourage member schools to sponsor volleyball. It was requested that three copies of the financial report from the regional tournament manager be sent to the participating schools (one to the principal, athletic director and volleyball coach).

Bunny Daugherty agreed to construct, for the regional managers, a guideline for a financial statement to be filled out after the regional tournaments.

It was felt that a decision should be made at the regional meeting as to how the program sales should be conducted and what options the tournament managers have in paying for the expense of the program. The Committee suggested: if a school contributes to the printing, advertising, etc., they should share in the profits of the program; if one school pays for the printing, advertising, etc., they do not have to share in the profits of the program.

The Committee set the time for the State Tournament to be 11:00 A.M. for the semi-finals (matches to be played at the same time) and the final to be played at 1:30 P.M. General admission fee for the semi-final and finals was recommended at \$4.00 for adults and \$3.00 for students.

The Committee recommended that line-judges be used for regional and state tournaments; either neutral line-judges be provided or each team shall provide one line-judge and that he/she not call own school's matches.

Brigid DeVries gave a financial report of the State Volleyball Tournament; receipts (ticket sales) \$3,360.00 and disbursement of \$9,022.98.

Ms. DeVries informed the Committee that she will conduct clinics for volleyball officials and coaches at the following sites and times: August 17, Bowling Green High School, 5:30 P.M.; August 18, Louisville Inn, 5:30 P.M.; August 19, Newport High School, 5:30 P.M.; August 20, Henry Clay High School, Lexington, 5:30 P.M.

The Part II National Federation exam will be given this year to officials wanting to work for a higher rating. This exam will be given on one date, September 21, 1981.

Assistant Commissioner DeVries called to the attention of the Committee members a change that should be made in the Officials Handbook published by the K.H.S.A.A. under "Uniforms". It should read "gym shoes" instead of "black shoes".

There was a lengthy discussion on the major rule changes for 1981-82 published by the National Federation.

Miscellaneous items included: A volleyball clinic is being held at the University of Kentucky on August 22, 1981. Various members of the Committee are to contact schools in their area that would be interested in providing sites for the regional volleyball tournaments.

There being no further business the meeting adjourned.

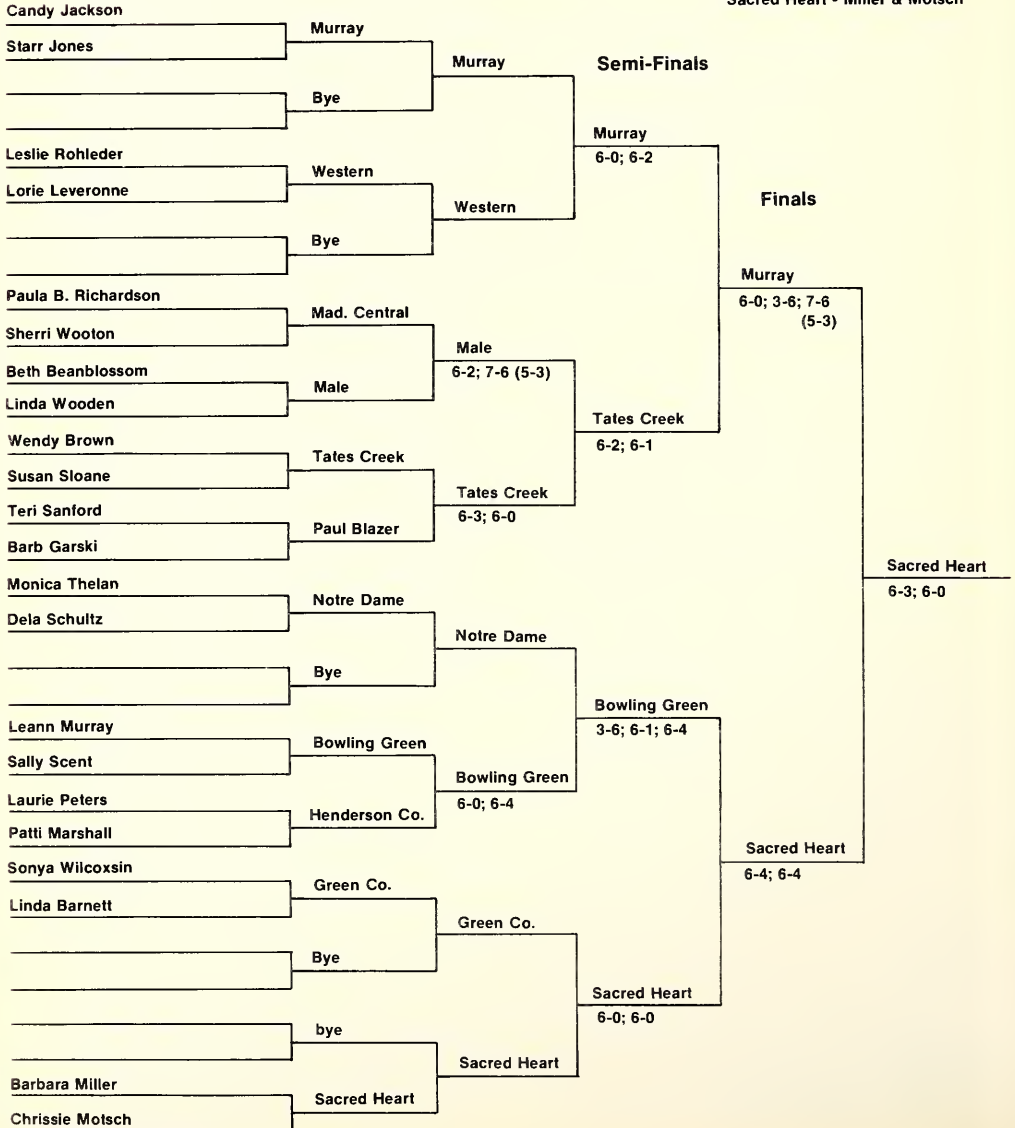

## PUBLICATION CORRECTIONS

**RULE BOOK — Page 30** - Play at the top and **Page 50** - play in the middle - both plays refer to "crawling". Since we took crawling out of the definitions - cross out the plays. **Page 33** - rule 6-3-1, 4th line - delete "or a safety, other than a punt."

**CASE BOOK — Play 29** - in 2nd line it should be **A1** instead of **B**. **Play 7.4.3.** - reference is 2-3-6 instead of 2-3-4. **Play 9.3.1c** - delete in ruling "because **A1** is obviously out of the play."

**SIMPLIFIED AND ILLUSTRATED — Page 16** - top - change 15 yards to 5 yards. **Page 90** - bottom - change touchdown to field goal.

1. **PLAY:** R1 makes a valid fair catch signal: (a) while K1's high punt is beyond the scrimmage line; or (b) while K1's high punt is 5 yards short of crossing the line of scrimmage. A stiff wind blows the ball back on K's side of the line in (a) and prevents the ball from crossing the line in (b). In (a) and (b), R1 catches the kick on K's side of the line. R1 advances in (b).

**RULING:** The signal in (a) is valid as the ball is beyond the line of scrimmage at the time R1 signals. The resulting catch is not a fair catch but the ball becomes dead when caught. The covering official should sound his whistle to prevent any advance. R1 has protection only on R's side of the line. The kickers may catch or recover the kick on K's side of the line and advance. In (b), the signal is illegal as the ball was not beyond the line at the time of the signal. The play in (b) will be allowed to continue until the down ends at which time enforcement of the penalty for the illegal signal will be considered (2-3-2, 5; 4-2-2g; 6-5-4; 6-5-6 Pen.; 10-3-1a)

**COMMENT:** If the ball did not become dead after R1 catches it on K's side of the line, it would give R1 an advantage (because of the valid signal) not intended by the rules. The valid signal by R1 alerts the kickers that R1 gives up any attempt to advance the ball in return for protection beyond the line.

2. **PLAY:** A1 breaks into the clear on his own 40-yard line. B1 and B2 move into tackle A1. A1 veers into B1 and initiates contact with his helmet in an attempt to punish his opponent. A1 fumbles after making contact and B2 recovers on the 50-yard line.

**RULING:** Spearing foul on A1. Team B may retain possession by declining the penalty. A1 is disqualified from the game whether the penalty is accepted or declined. Disqualification is a separate procedure not subject to acceptance or declination of the penalty. A disqualified player must always be removed. (2-29; 10-5-4)

3. **PLAY:** A1 is illegally in motion at the snap. A2's forward pass is in flight when B1 spears A2. The pass falls incomplete.

**RULING:** This is a double foul. The penalties cancel and the down is replayed. B1 must be disqualified even though a distance penalty is not assessed. (10-2-1a; 10-5-4)

4. **PLAY:** K1's punt is high and not very deep. A strong wind blows the punt back to K's side of the line where K2 gives a fair catch signal and catches the kick. Team R players stop short of contact after the signal but pursue and tackle K2 after he advances.

**RULING:** A fair catch signal by the kickers is always an illegal signal. Only members of the receiving team can make a fair catch in specific situations and by implication only receiving team members can signal. The penalty for the illegal signal occurs during a loose ball play and if accepted, would be enforced accordingly. (2-3-2, 5; 6-5-1; 6-5-6 Pen.; 10-3-1a)

5. **PLAY:** A1 throws a forward pass across the line which is touched by eligible A2 and is muffed high into the air. While the muffed ball is in the air, (a) ineligible A3 blocks B1 away from the ball; or (b) ineligible A3 touches the ball in an attempt to catch it.

**RULING:** Legal action in (a) but pass interference in (b). After A2 touches the ball, eligible offensive team players may use hands or arms. Pass interference restrictions for eligibles have ended. However, an ineligible Team A player may not touch the pass until a Team B member has touched it. The ineligible, however, may block an opponent to keep him from getting to the ball or to help a teammate in securing possession. (7-5-5c; 9-2-1c)

6. **PLAY:** K1's punt is beyond the line when R1 signals for a fair catch on R's side of the line of scrimmage. However, the punt comes down on K's side of the line of scrimmage and is recovered by R2.

**RULING:** The signal by R1 is not illegal since it was made beyond the line of scrimmage and between the goal lines and at a time a fair catch could be made. The play will be blown dead immediately when R2 recovers the kick since the signal by R1 has alerted the kickers that there would be no advance. (2-3-2, 3; 6-5-4)

7. **PLAY:** R1 signals for a fair catch on K's side of the line of scrimmage. However, the kicked ball comes down on R's side of the

scrimmage line where it bounces in the air and is recovered by R2.

**RULING:** The signal by R1 is illegal since it was made where a fair catch could not be made. The penalty is enforced as any loose ball penalty. The kickers may either have a replay of the down following the 5-yard penalty assessed against R or they may take the results of the play. (2-3-6; 6-2-6; 6-5-6 Pen.; 10-3-1a)

8. **PLAY:** A1 throws a forward pass from the 50-yard line. While the ball is in the air, A1 is roughed by B1. Thereafter, A2 catches the ball at B's 20-yard line and is downed on the 15-yard line.

**RULING:** Team A may either take the results of the play or accept the penalty for the roughing committed by B1. If A accepts the results of the play, they will have the ball on B's 15-yard line. If A accepts the penalty, it will be enforced from the previous spot and the down will be replayed, or if it results in a 1st down, it would be a 1st down for Team A from B's 35-yard line. The foul occurred during a loose ball play and the acceptance of the penalty dictates that the foul be enforced from the previous spot. (9-3-3; 10-3-1a; 10-3-2)

9. **PLAY:** A1 throws a forward pass behind the line to ineligible A2. A2 catches the ball and while still behind the line, throws a forward pass beyond the line. While the incomplete pass by A2 is in the air: (a) A3 interferes with B1; or (b) B1 interferes with A3.

**RULING:** The pass from A1 and A2 is an illegal pass. However, the pass thrown by A2 is a legal forward pass, in both (a) and (b). In (a), it is a multiple foul by Team A. Team B will have a choice of either accepting the penalty for the illegal pass or the penalty for the pass interference. In (b), the foul by B1 causes this to be a double foul and the down will be replayed. The fact that an illegal pass was thrown prior to the legal pass does not cancel the pass interference restrictions. (7-5-2c; 7-5-6; 10-2-1a)

10. **PLAY:** Fourth and 8 for K from their own 35-yard line. The snap from center is bad and the ball is muffed by K1. K1 attempts to scoop up the ball, and has it for a moment but muffs it again. As the ball is rolling loose behind the line, K1 kicks the ball downfield. While the ball is in flight, and before it is touched by any player of either team, it strikes K2 on the helmet while K2 is 15 yards beyond the neutral zone. The ball bounces downfield and rolls dead on R's 25. The covering official subsequently blows his whistle with no player of either team in possession of the ball.

**RULING:** When K1 kicked the loose ball, it was an illegal kick. No player shall intentionally kick a ball other than a free kick or scrimmage kick. A scrimmage kick may be either a punt, drop kick or place kick from behind the scrimmage line before team possession has changed. A place kick is a legal kick made while the ball is in a fixed position on the ground or on a tee. A drop kick is a legal kick by a player who drops the ball and kicks it when it touches the ground or as it is rising. A punt is a legal kick by a player who drops the ball and kicks it before it touches the ground. The action of K1 does not fit any of these definitions. The act is illegal. The 15-yard penalty, if accepted, would be enforced from the spot where K1 kicked the ball. If the penalty is declined, the ball would belong to Team K at the 25-yard line since only on a legal kick does the ball belong to the receivers if no team is in possession at the end of the down. The fact that the ball touched K2's helmet is disregarded. (2-15-1, 2, 3; 6-2-3; 9-6-2)

11. **PLAY:** Fourth and 3 for K from their own 10-yard line. A scrimmage kick by K1 is muffed beyond the line by R1 and rebounds back into K's end zone where it is simultaneously recovered by opposing players.

**RULING:** Touchdown. When any scrimmage kick is out-of-bounds between the goal lines or becomes dead inbounds between the goal lines while no player is in possession or inbounds anywhere while opponents are in joint possession, the ball is awarded to R. Since the kick was muffed beyond the line and there has been no possession, it is still a kick into K's own end zone. If K is in possession at the end of the down, it is safety. If R is in possession or there is joint possession, it is a touchdown. (4-2-2e; 6-2-7; 8-2-2)
