KHSAA Schools Urged to Involve Students, Faculty

Special Kodak Liberty Ride Festival Scheduled May 18

Students and adults at KHSAA Schools will have an opportunity this May to participate in a special event that will benefit a program to help students cope with alcohol and drugs.

The Kodak Liberty Ride Festival, to be held in 100 cities on May 18, is a national bicycle ride that will support America's Family Album, a project designed to benefit the renovation of the Statue of Liberty and Ellis Island. In Kentucky, event sites are Lexington and Louisville.

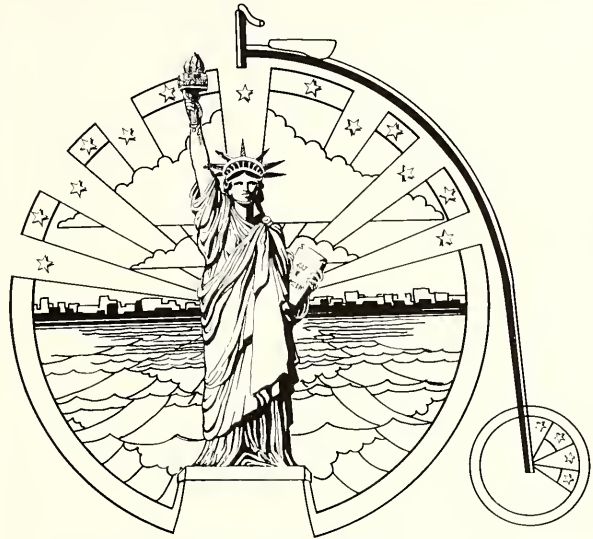
Some of the monies received via the event will fund Target, a program to help students cope with alcohol and drugs that is administered by the National Federation of State High School Associations. The National Federation will use a portion of funds received for Target through the ride to help the Kentucky drug and alcohol education information program.

The Ride Festival will benefit America's Family Album, which supports Kodak's pledge for restoration of the Statue of Liberty and Ellis Island. Participation in the Ride Festival will help the \$230 million goal for renovation of two of America's most important landmarks. The event will afford many students (and others) the valuable opportunity of helping our nation—while having fun.

Coordinating activities for the ride is Bicycle USA, a national cycling association. Scheduled events include bicycle tours, entertainment programs, picnics, and outdoor activities.

The festival will conclude with the "America Rocks" concert to be televised live via satellite from the Louisiana Superdome in New Orleans to festival sites across America.

Those who enter the ride will send in a \$20.00 coupon (supplied through KHSAA) to the Eastman Kodak Company (if pre-registering; sign-ups on the day of the event will be \$22, the price \$25 if one enters in New Orleans). **It is imperative that participants from KHSAA Schools use National Federation coupons (which have the NF logo and are supplied through KHSAA to benefit National Federation and state association projects.** Other coupons will not benefit the National Federation Target program. Each entrant will receive:

- A commemorative T-shirt;
- Free refreshments;
- Admission to the local viewing of a live satellite-transmitted rock concert;
- Admission to "America's Family Album," an electronic picture collection at Liberty Island.

A related project is America's Family Album. This electronically-stored collection of photos, to be located on Liberty Island, is a family album for all Americans. To enter, you need to send a photo and \$10 fee (entrants in the ride are given entry in the Album as part of their fee). The nationwide collection will be at Ellis Island for decades, and visitors will be able to call up their own pictures or those of relatives.

The video disks on which pictures will be stored will allow for decades of high-quality viewing and fast access to photos. Though contributions will

receive a special identification number, photos may be called up by family name, country of origin, and other such cross-indexes. This will allow visitors to view the "family tree." Participants may send in photos of themselves or ancestors, but the \$10 fee should be provided for each photo sent. Photos cannot be returned. The storage system will accommodate virtually any number of pictures.

Thousands of photos have been received, including those of President Ronald Reagan's family and Vice-President George Bush's family. Photos can include individual school portraits; athletic team, cheerleader, and club pictures; classroom photos; and graduation snapshots.

The exhibit for viewing pictures will open on July 4, in concurrence with the unveiling of the refurbished Statue of Liberty.

TENNIS COMMITTEE MINUTES

The Tennis Committee met on Tuesday, February 25, 1986 at the K.H.S.A.A. office in Lexington. Assistant Commissioner Brigid L. DeVries called the meeting to order at 1:30 p.m. Committee members present included Jerry Johns, Joe Kroh, Jeff Frisch, Becky Watson, Wilson Sears and Tom West.

The first item on the Agenda was a discussion of regional tournament sites. Changes in regional sites to date included the Northern Kentucky Region being hosted by Lloyd High School. Other regional sites are being secured at the present time.

The Committee reviewed the Regional Information Sheet and suggested the following changes:

- 1. That a provision be made for a three-way tie in team scoring.
- 2. That Regional Managers are sure that the Certificates of Eligibility are in before participants are allowed to play.

A deadline when regional entries are due was set for May 12, 1986. Regional Managers are advised to schedule no tournament play on school time.

The next item on the agenda was a discussion of the seeding committees. Potential committee members were selected and will be notified by mail. The seeding committees will meet in Lexington the Tuesday before the State Tennis Tournament.



1986 Kentucky State Wrestling Association

Welcome to the 1986 Kentucky State Wrestling Association (KSWA) season. KSWA is affiliated with AAU/USA and sanctions youth wrestling for boys ages 5 and over. There are a total of 81 age/weight divisions in which boys may compete. Both Freestyle and Greco, the two Olympic styles of wrestling, will be taught. Freestyle, which is the most similar to high school wrestling, will be featured at all tournaments. The KSWA season will run from March 1, 1986 through June 14, 1986. A total of 11 tournaments will be held across the state, including a state championship tournament in Louisville, where state champions will be crowned in all 81 age/weight divisions. Medals will be awarded to 1st, 2nd and 3rd in each division at all tournaments. Individual memberships are \$8 which entitle a wrestler to compete in all KSWA tournaments. PROPOSAL 48 - NEW NCAA REGULATION PASSES

Effective immediately, incoming students to an NCAA member institution who wish to immediately participate in intercollegiate athletics at the Division I level must have maintained a 2.0 grade point average in a core curriculum including at least three years English, two years math, two years social science, and two years of physical or natural science; as well as having attained a 700 combined score on the SAT verbal and math sections or a 15 composite score on the ACT; and be a high school graduate.

When the full body of the NCAA Convention passed the rule at its January meeting, it passed the by-law, as amended to phase in the requirements over a two year period. The amendment stated that eligibility may be attained for incoming athletes after August 1, 1986 and prior to August 1, 1987 by one of five possible combinations --

The By-Law, which follows By-Law 5-1-(j), on pages 92 & 93 of the NCAA Handbook, also allowed for an exception which states, "An exception may be granted by the NCAA Eligibility Committee for a student who left high school after completion of his junior year or during his senior year to enter a member institution under an early admissions program open to students solely on the basis of outstanding academic performance and promise, and provided that for the last four semesters completed in high school, the student maintained an accumulative grade point average of 3.5 (based on a maximum of 4.0) and ranked in the top 20 percent of the students class, and that the student met all of the requirements of a qualifier except for graduation from high school."

NOTICE TO BASEBALL/SOFTBALL OFFICIALS

One big change for this year's playing rules is the requirement that in addition to the batter, all runners, on deck batters, and all players in the coaches box must wear a NOCSAE approved helmet, and the helmet must have the appropriate warning label affixed to the outside in a visible location. No coach should allow helmets to be used that are not NOCSAE approved. This is not optional, this is mandatory. The warning labels may be requested from sporting goods stores in your area, or from the manufacturer from who you purchased your helmets.

IMPORTANT NOTICE TO ALL KHSAA OFFICIALS

Effective with this year, 1986, officials in baseball, basketball, football, soccer, softball, track, volleyball, and wrestling will be required to re-register between May 1, 1986 and June 30, 1986. New officials will still be permitted to register until the current deadlines. Registration forms will be mailed during April to all currently registered officials. If your address is not correct or you have had trouble receiving mailings, magazines, etc. from this office, you should contact Ms. Pruitt immediately to have her double check your address. Officials not re-registering during the May-June period will be assessed a \$25.00 late charge in addition to the normal fees required. There will be no waivers from this policy or fee.

If you do not receive your re-registration form prior to June 1, you should contact this office immediately. Non-receipt of information will not be an acceptable reason for waiver of the late fee.

The new registration schedule is due in part to a new reciprocal agreement between the states adjacent to Kentucky in an effort to allow the ratings, years service, and other items, to transfer from one state to another.

The procedure to register in multiple states is as follows -- Register with the High School Athletic Association in your state of residence. Pay the normal fee required for registrants in your home state. You then must pay a \$10.00 multiple state registration fee. This fee entitles you to officiate contests in all states participating in the multiple state agreement. You will be required to pay no other additional fees for registration, other than those that may be assessed by a local officials association as dues. Ratings, years of service, and all other pertinent information will be forwarded to all participating states upon receipt of the \$10.00 fee. If you have any questions, please contact K.H.S.A.A. 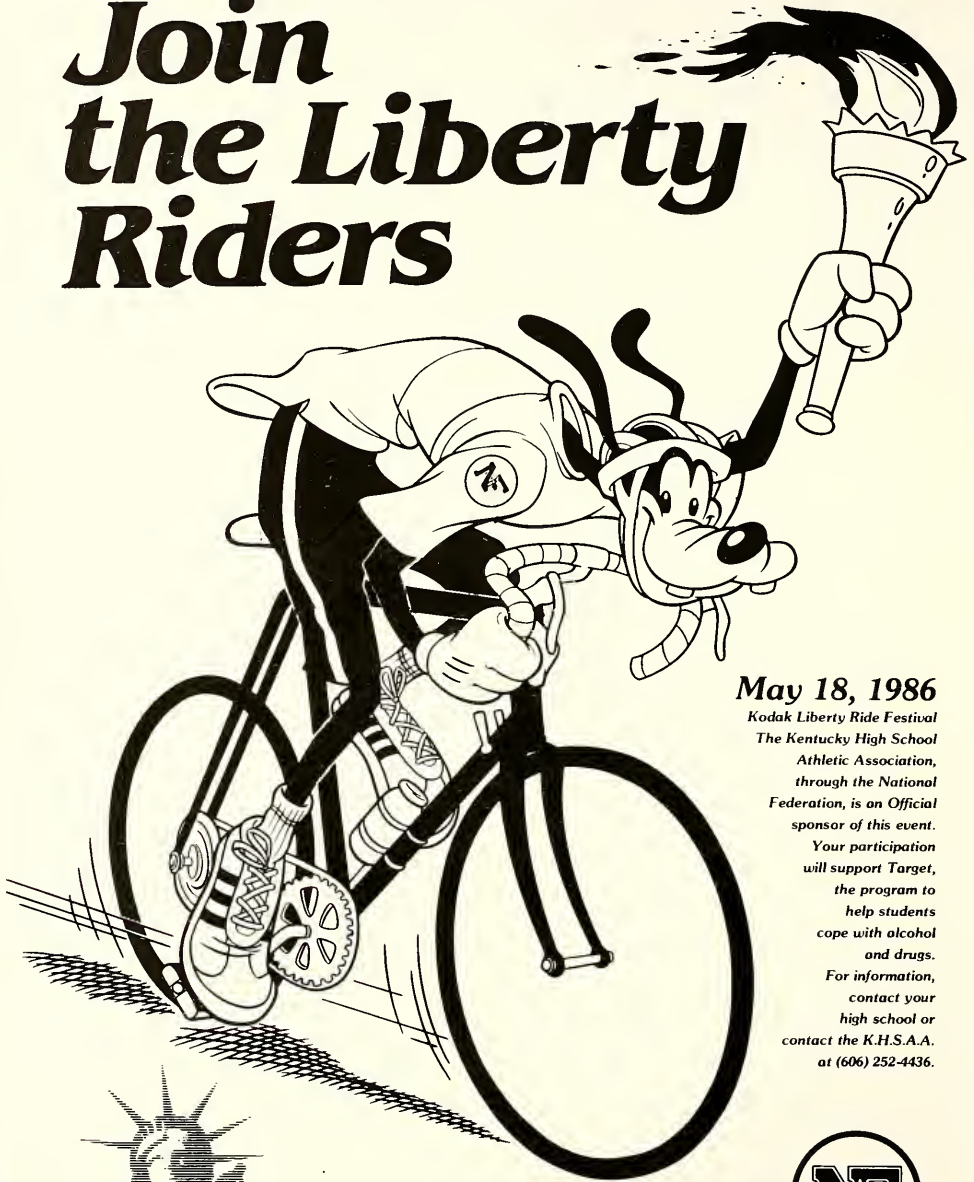

A MOMENT OF ANGER PUTS CAREER IN JEOPARDY

(Editor's Note: The following editorial is reprinted from the Texas Interscholastic League, The Leaguer. It is based on incidents which have actually occurred. The sequence of events have been altered to protect any particular school or school personnel. The disposition of penalties by the State (Texas) Executive Committee are penalties which have been assessed in recent years.)

There was tension in the room. It filled the air. It hung invisible, yet clearly present on the shoulders of a troubled coach. It drew blank stares from taut faces of students and parents. Attentive reporters and television camera crews waited the outcome. While a panel of committee members alternated questions of inquiry, the coach became increasingly more unsettled.

This was a meeting of the executive committee. The purpose? To determine whether a school employee had been guilty of misconduct. No one wanted to be there. Only the most twisted mind could have enjoyed the proceedings. The charges were clear. At the end of a football game, the young coach had stormed across the field to the game referee. As the referee attempted to exit the playing field, the coach placed his hands on the official. The coach testified that he "placed" his hands on the official. The official attested that he was "hit" by a sharp blow with the butt of the hand.

As a crowd of players and fans gathered around and as other officials attempted to talk the coach away from the referee, something happened. No two persons can agree on all details. But the result of what happened changed a number of lives that evening. Either the coach struck the referee or the referee shoved the coach. It makes no difference whose story is right. What is tragic is what happened after.

As officials attempted to separate the

coach, several players got involved. One player struck an official with his helmet. Another player delivered a blow with his fist to the back of the umpire. The umpire went down to his knees as two fans arrived. By this time, a skirmish had begun with the players and fans from both schools exchanging angry curses and blows. A cheerleader received a three-inch gash on her forehead. A parent took a blow to the head from a stadium seat. An assistant coach had his shirt ripped off. When school officials finally cleared the field, it was discovered that an 11-year-old boy had sustained a multiple fracture to his tibia.

"Coach, did you strike the official?" The answer came slowly, haltingly, almost apologetically. "All I wanted to do was get an explanation. I never intended for things to get out of hand. I have never before been involved in anything like this in ten years of coaching."

"Are you aware of your responsibility to accept decisions of officials without protest? Did your principal or superintendent go over conduct rules with you prior to the season? Why were there no security guards present? Did you realize that your players would follow your example — good or bad?"

All these questions were posed. Either the coach or school superintendent attempted to answer as best they could.

What happened to the coach? The players? The school? The football team?

The coach was suspended from coaching for the remainder of that season and the next. He was informed of his right to appeal. He chose not to.

The two players involved in hitting the officials were suspended from any future participation in U.I.L. contests. One player was a senior, the other a junior.

The school was suspended from football for the remainder of that season and placed under probationary conditions for two

additional years.

The parent hit by the stadium seat received an out-of-court settlement from a model citizen who had lost his temper in the melee. The officials never came back to that school and the umpire retired from officiating. After a 22-year career, he decided it wasn't worth it.

This story should not have happened. It was not caused by a troublemaker. It was caused by one of the outstanding teachers in the community. Under stress and considerable pressure to win, he lost his composure. Thousands of times he had met frustration, and thousands of times he faced it stoically. The one time he lost control, he set off a series of events that changed his life. His career is now in jeopardy. It is a sad story, but nevertheless a preventable tragedy.

The problems of maintaining control at athletic events remains a top priority for all school officials. If extracurricular activities are to provide an educational experience, strict security and the best sportsmanship must be the rule rather than the exception. With increased violence in college and professional sports, the task of keeping order in high school activities becomes a never-ending duty. The challenge to provide a safe environment must be met.

As thousands of coaches prepare their teams for games, the public is forever reminded of benefits provided by coaches. This illustration of momentary poor judgment cannot erase the positive contributions made by coaches. It does, however, illustrate how a single incident can erase, or, at best, blemish an otherwise successful career. The responsibility of the team is on the coach. The responsibility of the coach is on the school administration, but more immediately and final — on the coach's own maturity and judgment.

The State of California has requested through the National Federation of High School Athletic Associations that the metal cleats be permitted for their baseball programs. Each state has received their information concerning their request and they are seeking to have the rule on the metal cleats reestablished.

However, the Kentucky High School Athletic Association has gone on record supporting the present rule and would not favor any change that would allow the metal cleat to be used. Please be advised of this when your area schools are sent a questionnaire concerning the metal cleat.

SITUATION #1: B1 appears at bat wearing a helmet that does not bear an exterior warning label, and is detected by the umpire
RULING: The umpire will require the batter to secure a legal helmet 1-1-5

SITUATION #2: B1 appears at bat wearing a helmet that bears an exterior warning label, but the helmet does not have the NOCSAE stamp. Since the coach verified to the umpire-in-chief during the pre-game coaches/umpires conference that his players were dressed in compliance with the rules, this shall include batting helmets

RULING: The helmet is legal only if the coach has verification that the helmet was manufactured after July 22, 1982, and that it meets NOCSAE standards 1-1-5

SITUATION #3: The coach of the defensive team asks the umpire to inspect the batting helmets worn by runners occupying first and second base

RULING: Umpires are not required to inspect helmets. However, if an umpire detects a helmet without an exterior warning label, that player shall obtain a legal helmet 1-1-5

SITUATION #4: As B1 steps into the batter's box, the umpire notices that B1's helmet does not bear an exterior warning label
RULING: The umpire shall order the player to obtain a legal helmet, and then the umpire shall warn the player's coach that the next player to violate the rule shall be ejected 1-1-5

SITUATION #5: Prior to the game, or during the game, the coach notices that the warning label on one of his team's batting helmets has come off and is not to be found

RULING: The coach may affix the proper warning label to the helmet's exterior, which would then be in compliance with the rule 1-1-5

SITUATION #6: The coach goes to a sporting goods store to obtain exterior warning labels for his team's helmets. However, the sporting goods dealer does not have any exterior warning labels available, or does not know what he should do to obtain any

RULING: If exterior warning labels are not available through local dealers and suppliers, the coach should contact the manufacturer. If he is still unable to obtain a supply of labels, he should contact his state association and let them know of the problem. In an emergency situation, in order for helmets to meet the rule requirements, so that they can be used in a game, a coach may wish to have exterior labels prepared by using the suggested NOCSAE warning statement

DO NOT USE THIS HELMET IF THE SHELL IS CRACKED OR DEFORMED OR IF INTERIOR PADDING IS DETERIORATED.

SEVERE HEAD OR NECK INJURY, INCLUDING PARALYSIS OR DEATH, MAY OCCUR TO YOU DESPITE USING THIS HELMET. NO HELMET CAN PREVENT ALL HEAD INJURIES OR ANY NECK INJURIES. A PLAYER MIGHT RECEIVE WHILE PARTICIPATING IN BASEBALL OR SOFTBALL. 1-1-5, NOCSAE Manual

SITUATION #7: The umpire notices that a player in the coach's box is not wearing a protective helmet

RULING: The umpire will require the player to obtain a legal helmet. If the umpire issues a warning to the coach that the next player to violate the rule shall be ejected, then upon the next occurrence, the violator would be ejected 1-1-5

SITUATION #8: R1 is on third and R2, on second. As B3 attempts to hit, F2 touches the tip of the bat or steps upon the plate to catch the pitch

RULING: B3 is awarded first base. R1 and R2 remain on third and second base respectively, since neither was staying or forced to advance. 8-3-1-c

SITUATION #9: The umpire observes F2 wearing a loose-fitting bracelet. Upon closer examination the umpire discovers the he bracelet describes F2's diabetic condition

RULING: The umpire will instruct F2 to securely tape the bracelet to the wrist in such a way that it is visible, but so that it does not pose a potential danger to other players. Medical alert bracelets and necklaces are not considered jewelry 1-1-6 Note

SITUATION #10: As B1 enters the batter's box, the umpire notices that B1's ring finger has an excessive amount of tape around it. A closer look reveals the outline of a class ring

RULING: Illegal. All jewelry is prohibited. Since the coach was to have verified to the umpire-in-chief during the pre-game coaches/coaches conference that all his players are dressed in compliance with the rules, he shall be warned that the next player to violate the rule shall be ejected 1-1-6 Note

SITUATION #11: In the sixth inning, S1 replaces R2 at second base. While S1 runs to second base to get in position, his neck chain bounces up and down around his neck. The umpire tells S1 that neck chains are illegal and that it has to be removed. S1 says that it is a medical alert necklace and that he has to wear it. The umpire then asks S1 if it is taped to the body. S1 says that it is. Having his doubts, the umpire asks S1 to show him, at which time S1 raises his hands to the body.

RULING: The umpire shall require S1 to tape the necklace to the body, so that it remains visible. 1-1-6 Note

SITUATION #12: While taking his warmup pitches, the umpire notices F1 wearing a medical alert bracelet on his pitching hand. Is F1 allowed to continue wearing the medical alert bracelet on the pitching hand?

RULING: If a medical alert bracelet is to be worn by the pitcher, it shall be worn on the nonpitching hand 1-1-6 Note

SITUATION #13: Prior to the game, the coach of the visiting team informs the umpire-in-chief that he does not wish to play the game on bases with tapered edges

RULING: If the bases are two-and-a-half inches thick and meet other National Federation rule specifications, the bases are legal, therefore, the game shall be played. 1-3-1

SITUATION #14: With no outs, and R1 on third and R2 on second, B4 hits down the left field line. R2 maliciously runs over F5 as R1 touches home plate

RULING: The ball is dead immediately. If R2 initiated malicious contact with F5 before R1 touched home plate, then R2 is out and ejected, and B1 would have to return to third base. If R2 initiated malicious contact after R1 had touched home plate, R1's run would count. 2-5-3, 3-3-1-1

SITUATION #15: R1 is on second base, B2 is obstructed and thrown out at first. R1 attempts to advance to third and is tagged out

RULING: R1 is returned to the second and B2 is awarded first base. 8-3-1-c

SITUATION #16: With the bases loaded, B1 singles. R1 scores, then maliciously runs over F2.

RULING: The ball is dead immediately. R1's run would count and he would be ejected for unsportsmanlike behavior. 2-5-3, 3-1-1-1

SITUATION #17: In a close play at second base the umpire calls R1 out. The first base coach rushes up to the umpire, wildly waving his hands above his head and insisting that the umpire was in error.

RULING: The umpire need not warn a coach or player before ejecting him. Blatant, unbecoming behavior is cause for immediate ejection, otherwise the umpire may first issue a warning. 3-3-1-k

SITUATION #18: R1 is on third base. F1 starts his pitching motion, B2 requests "Time," which the umpire does not grant. The batter steps out of the box and the pitcher stops in the middle of his delivery.

RULING: The umpire shall call "Time," and if in his judgment, neither player's actions were deliberate, he shall order play to start anew. 6-2-4-d

SITUATION #19: With R1 on third, R2, who was on second, tries to steal third as B3 is obstructed.

RULING: B3 is awarded first base and R2 is returned to second base, since he had no right to steal an occupied base. 8-3-1-c

SITUATION #20: As F1 starts his windup, B1 jumps out of the batter's box for no apparent reason. F1 does not deliver a pitch.

RULING: The umpire shall call "Time," and if in his opinion, the batter deliberately tried to cause the pitcher to balk, he shall eject him. 6-2-4-d, 3-3-1-b

SITUATION #21: With a count of three and two on B1, with two outs, B1 steps out of the batter's box without being granted "Time" and F1 throws a low pitch that bounces in the dirt and goes to the backstop. Does the ball remain alive?

RULING: As soon as the pitch is delivered, the umpire shall call it a strike, in which case the batter is declared out immediately for the third out 6-2-4-d
