MINUTES OF THE BOARD MEETING

March 16, 1990

The Board of Control of the Kentucky High School Athletic Association met at the Greenwood Executive Inn in Bowling Green, Kentucky on Friday, March 16, 1990. The meeting was called to order at 8:30 a.m. by President Sam Chandler with all Board members, Commissioner Tom Mills, Executive Assistant Billy Wise, Assistant Commissioners Brigid DeVries and Louis Stout, Sports Information Director Julian Tackett and Earl Cox present. Mr. Harry Loy was present representing the State Department of Education. Also present was Dr. Maurice Clay, Mr. C.K. Henry gave the invocation.

President Chandler requested that the Board approve an amendment to the Agenda to include an item under 4. -- Executive Session. Huston DeHaven moved that this item be added to the Agenda. C.K. Henry seconded the motion which passed unanimously.

Commissioner Mills introduced Dr. Clay to the Board and explained that he had been working on an oral history of the K.H.S.A.A. for the past twelve years.

Mr. Chandler then called on Mr. Jerry Thompson who had requested an appeal on behalf of his daughter, Annette. Due to the fact that Mr. Thompson did not appear, the Commissioner discussed the information on the Transfer Form. Following Mr. Mills presentation, David Points made a motion, seconded by Huston DeHaven that the ruling of the Commissioner be upheld in this case. The motion carried unanimously.

The next appeal was presented by Commissioner Mills on behalf of Rick Garr. Mr. Garr had requested an appeal of By-Law 4, Section 1(a), as it pertained to his son, Rickey. Following Mr. Mills presentation and recommendations to the Board, Sandy Allen made a motion that Rickey Garr be allowed to participate in athletics during his senior year at Trinity High School. C.K. Henry seconded the motion which passed unanimously.

The next appeal was also presented by Commissioner Mills on behalf of Mr. John D. Wilson, Red Bird Mission School. Mr. Wilson asked that Kenneth Smith be given an extra year of eligibility during the 1990-91 school year. Kenneth was unable to participate in athletics during the 1989-90 year due to illness. Following a discussion of Kenneth's situation, Eddie Saylor made a motion, seconded by Charlie Miller that the Board grant Kenneth an extra year of eligibility. The motion passed unanimously.

Charlie Miller made a motion that the minutes of the January 19-20, 1990 meeting be approved. C.K. Henry seconded the motion which carried unanimously.

Alvis Johnson moved, seconded by Eddie Saylor, that all bills of the Association for the period beginning January 1 and ending February 28, 1990, be approved. The motion carried unanimously.

Commissioner Mills announced the results of the recent election for new Board of Control members.

Section 4 (Regions 7 & 8):

Harry Jansing, Trinity High School - 14 votes

James Sexton, Eastern High School - 13 votes

Joe Liedtke, DuPont Manual High School - 11 votes

Section 3 (Regions 5 & 6):

Ray Story, Hardin County Schools - 29 votes

Mr. Chandler then read an appeal he had received from Mr. James Sexton regarding the recent Board election. Following

a lengthy discussion of Mr. Sexton's appeal, Liz Trabant made a motion, based on the attorney's opinion, that the election of Father Harry Jansing to represent Regions 7 and 8 on the Board of Control was held in strict compliance with the Procedures of Election as outlined in Section 2 of Article IV of the K.H.S.A.A. Constitution and By-Laws. The motion was seconded by David Points and passed by a vote of 10 in favor and one opposed. Bob Rogers abstained.

Liz Trabant moved, seconded by C.K. Henry, that the Board go into Executive Session. The motion passed.

Bob Rogers made a motion, seconded by Jack Portwood, that the Board return to Open Session. The motion passed unanimously.

The Chairman of the Executive Committee, Sam Chandler, then presented the report of the Executive Committee.

1) That the Commissioner present to the Board by the April meeting an evaluation plan of each staff member;

2) That the Commissioner present to the Board a seating plan on the Boys State Basketball Tournament.

Bob Rogers made a motion that the report of the Executive Committee be accepted. Jack Portwood seconded the motion which passed unanimously.

Exec. Asst. Wise reported that \$479,727.00 in ticket sales had been received through this date for the Boys State Basketball Tournament. Advanced ticket sales for the Girls State Basketball Tournament had netted approximately \$22,370.00. He also advised the Board that a complete report would be presented at the April Board meeting.

Commissioner Mills advised the Board that he had contacted all schools involved in basketball redistricting and had asked for suggestions or comments. Most of the changes in the districts are due to consolidation. The schools requesting to be changed or added to a district are as follows:

District 10 - add Butler County

District 14 - add Greenwood

District 17 - drop East and West Hardin

add Central Hardin

District 42 - add Lexington Christian (1992)

District 43 - add Paul Lawrence Dunbar

District 59 - drop Dorton and Virgie

add Shelby Valley

District 64 - add Rose Hill

Bob Rogers made a motion that the Proposed Basketball Redistricting Report be accepted as presented. C.K. Henry seconded the motion which passed unanimously.

Commissioner Mills gave a report of the following committees:

1) Building Committee - The committee had traveled to Indiana and Ohio to visit three Halls of Fame.

2) Hall of Fame Committee - to meet in April.

Mr. Chandler appointed the Hall of Fame Committee as follows: All Board Members, K.H.S.A.A. Staff (Tom Mills, Bill Wise, Louis Stout, Brigid DeVries), Earl Cox, Dee Dawahare, Bob White, Mike Fields and Larry Vaught.

Mr. Henry then presented the All-Sports Committee Report as follows:

1) Recommended the following volleyball fees for 1990-91: Regular Season - \$22.50; Region \$25.00 - State regular - \$30.00

2) Beginning in 1990-91, track coaches and officials shall attend a track clinic every other year.

3) Beginning in 1990-91, one registered track official shall be present at the regional and sectional track meets.

- 4) Suggested that the "recommended" fee for one registered track official be \$35.00
- 5) Tabled the following item: that the 3200 meter relay and the girls triple jump be added to the track events
- 6) Recommended that surveys dealing with the same request may not be repeated for five years unless 20% of the member schools participating in that sport submits a written request to the Board of Control
- 7) Adopt the 1990 Proposed Softball Alignment as submitted.

Huston DeHaven moved to approve the recommendations of the All-Sports Committee. Eddie Saylor seconded the motion. Following a discussion of the report, the motion was amended to delete Item 4). The motion then passed unanimously.

Following a discussion on advertising for bids for the Boys and Girls State Basketball Tournament sites beginning in 1992, it was the feeling of the Board that bids be submitted for at least two consecutive years with an option for a longer term. The dates for the Boys Basketball Tournaments are scheduled for March 17-20, 1993, and the Girls Tournament dates are March 24-27, 1993.

Commissioner Mills discussed with the Board a request for Ballard High School to play in the Alaskan Shoot-out. Alvis Johnson made a motion, seconded by Eddie Saylor that this request be approved. The motion passed unanimously.

Mr. Mills presented to the Board several proposals to be considered by the 1990 Delegate Assembly. Topics included in the proposals are: Changes in the Limitation of Seasons in all sports; ineligible students being exempt from practice; increasing the Board's number to 22 members; reierendum votes.

The National Federation Annual Meeting material was distributed to the Board members. The meeting is to be held from July 2-6 in Minneapolis, Minnesota.

Mr. Wise advised the Board that hearings for the football

realignment will be held on April 18. He also advised that the next meeting of the Board will be held on April 19 and the Delegate Assembly will be meeting on April 20. All meetings will be held at the K.H.S.A.A. Office.

Following a discussion of the Second Annual Hall of Fame Classic basketball games to be held in December or January, Sandy Allen made a motion that these games be exempt from the 24-game limit. Charlie Miller seconded the motion which passed.

There being no further business, Bob Rogers moved to adjourn. Alvis Johnson seconded the motion which passed.

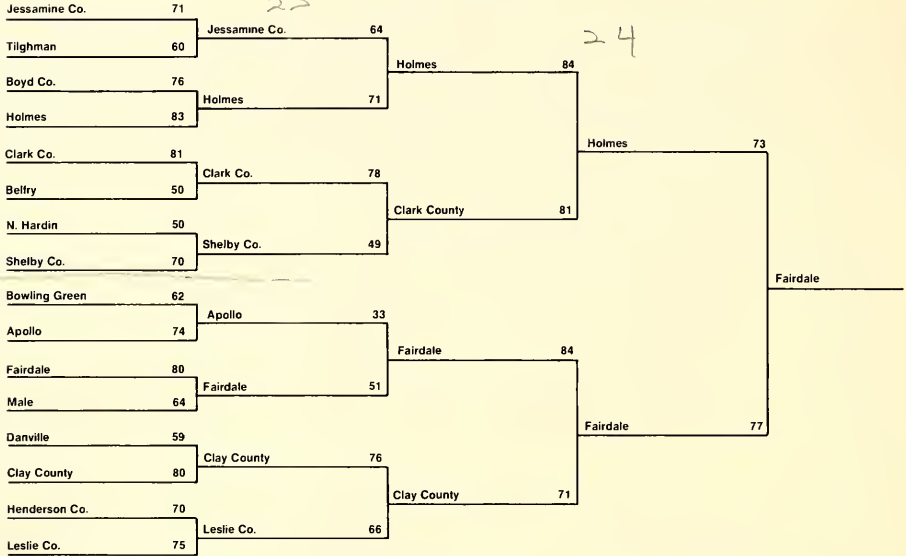

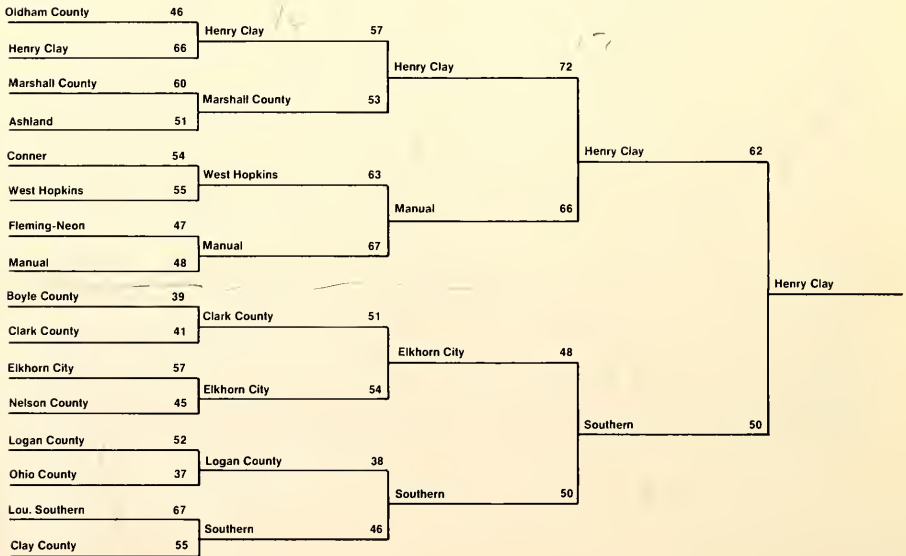

IMPORTANT NOTICE CONCERNING DISQUALIFICATIONS

By Board of Control action, all participants and/or coaches who are ejected from a contest for unsportsmanlike conduct shall be suspended from competition for a minimum of one game.

It also should be noted that officials who disqualify participants, and then do not report that disqualification to the Association office in a timely manner may face suspension from officiating!!

With this in mind, it is important to adhere to the following procedure should a representative of your school be ejected for unsportsmanlike conduct. 1) Be sure you receive a disqualification card from the contest official; 2) Contact this office in writing to request reinstatement of the participant; 3) Inform the participant/coach of the suspension. You will be notified by return mail as to the end of the suspension, and the date or day when the player/coach will be eligible to return to competition. Contest officials also are reminded to use an ink pen, to include the first and last name of the offender, and to press hard as the third copy is often illegible if done in pencil.

NOTE Any person who is suspended from a contest may not dress for that contest in game uniform. They will however be covered by the catastrophic insurance policy insofar as practice is concerned unless you are otherwise notified.

1990-91 MAJOR CHEERLEADER RULE REVISIONS



- Rule 1** During partner stunts/pyramids, spotter does not provide primary support of another person. Extension is a stunt in which supporting arm(s) of base(s) is fully extended above the head and the top person is standing in the hand(s) of the base(s).
 Suspended roll involves horizontal rotation with the top person having continuous hand/arm-to-hand/arm contact with a base(s) and/or spotter(s).
 Vault is a stunt in which the hands of the top person are used to assist in clearing the base.
- 2-3-2** A spotter is required for stunts in which the supporting arm(s) of the base(s) is fully extended above the head except for a chair, Russian lift, 3-person straddle/split lift, torch or double-base straddle/split catch.
- 2-3-4** A roll down must have a spotter at the head and shoulders of the top person who is not involved in anything but spotting.
- 2-4-1** A base shall not assume a back-bend position.
- 2-7-2** Tosses shall be directed vertically with the intent that the top person will be caught by bases in their original positions on the cheering surface.
- 2-7-6** Helicopters are not permitted.
- 2-8-1** Vaults must originate from the floor. Vaults from a mount/pyramid are not permitted.
- 2-8-2** Vaults from a pitch/toss are not permitted.
- 2-9-1** Stationary hanging pyramids with specific restrictions are permitted.
- 2-10-3** Top person on a suspended splits must have partial support only on her back thigh.
- 2-11-1** Front drops are not permitted unless most of the weight is first borne on the hands/feet to break the impact of the drop.
- 2-12-7** Cartwheel dismounts are not permitted.



1990 NATIONAL FEDERATION TRACK & FIELD RULE INTERPRETATIONS PART II



SITUATION #11: Is the "cloud nine" (air-filled pole vault landing pad) considered a legal landing pad?

RULING: Air-filled landing pads are presently considered as legal equipment for track and field competition as long as the pad meets the minimum dimensions as described in the 1990 Track and Field Rule Book. (7-4-4; 7-4-5)

SITUATION #12: The members of Team A's girl's 4 x 200 m relay team report to the clerk all wearing identical school-issued jerseys and shorts (which are not objectionable). Each runner is also wearing a white T-shirt under her jersey. In addition, the lead-off runner is wearing solid black leotards, number 2 is wearing solid light blue leotards, number 3 is wearing solid pink leotards and the anchor runner is not wearing a leotard. The relay captain informs the clerk that her coach has received permission from the meet director to compete wearing the black, light blue, and pink leotards. The starter, upon seeing the different colored leotards, instructs the relay captain to have at least two of the relay team members remove their leotards and gives them 5 minutes to comply with the uniform rule regarding relay teams. The coach of Team A immediately shows the starter a letter from the meet director authorizing a waiver of the uniform rule for relay teams.

RULING: The meet director, games committee or the vote of the coaches can supersede the track uniform rule. Therefore, Team A will not be permitted to start the race because team members are not wearing the same uniform (i.e. black leotard, light blue leotard and pink leotard). (4-3-4, 4-5-7)

COMMENT: It is possible that team members running the second, third or fourth legs may not remove their warm-ups until after the race has begun, and therefore, it would not be apparent that team members are wearing different colored undergarments. In the event this situation would happen, the relay team would be disqualified.

SITUATION #13: Prior to competition in the pole vault event, the judge informs all vaulters that the crossbar can only be positioned from a point 12 inches beyond the end of the stopboard (+12) to a position not to exceed 24 inches beyond the end of the stopboard (+24) in the direction of the landing pad. The judge also takes the time to actually show the vaulters the range of movement allowed on the equipment to be used. (a) A1 asks permission to position the bar at a +25, or (b) after B1 completes his vault, the judge discovers that B1 had purposely set the crossbar at +10 position.

RULING: In (a), the request will be denied. However, in (b), B1 is disqualified from further competition. (7-4-13)

COMMENT: It is a good practice for the judge of the pole vault event to review the range the crossbar may be moved with all vaulters by actually showing the vaulters where the limits are on the standards they will be using (+12 to +24). Also, it is recommended that the judge make an effort to check the setting of each vaulter prior to the actual vault. Therefore, any incorrect settings can be adjusted before a trial is taken. It is also recommended that meet management permanently fix the standards so that they can only be adjusted from the minimum to the maximum range. This could be done by drilling a hole through the base just outside the +12 and +24 settings and placing a bolt through the hole that would prohibit the movement of the crossbar beyond the approved range.

SITUATION #14: Approximately halfway through the conference meet, an electrical storm suddenly appears and in the interest of safety, the games committee decides to suspend competition and resume the meet the next day. When the meet was suspended, there were four competitors remaining in the high jump and the bar was at 6'5". A1 and B1 had cleared the height while C1 and D1 had failed their first attempt. A2 had not had a trial at this height when the storm hit.

RULING: The games committee was correct in suspending competition due to the hazardous weather. Unless there are conference, league or state associations rules which apply, all trials and marks made up to the suspension of competition shall stand. When competition is resumed, it shall begin at the point of interruption. Regarding the high jump, the bar shall be set at 6'5", A1 and B1 are still recorded as successfully clearing the height, C1 and D1 will have two trials remaining, and A2 three trials. All competitors should have the opportunity to warm up with the bar at any height. (3-2-6, 3-2-7)

SITUATION #15: During the running of the 4 x 2000 m relay, A2 is detected interfering with B1 as the two runners are entering the exchange zone. The inspector sees the interference and signals by waving a red flag overhead. At the conclusion of the race, the inspector reports the infraction to the head inspector, who immediately notifies the head finish judge that Team A is disqualified.

SITUATION #16: B1 is the only remaining competitor to successfully clear 6'7" in the high jump. He requests that the bar be raised to 6'9" so he can set a school record. After the bar has been raised to 6'9", B1 removes his shoes prior to clearing the new height. The coach of Team A protests, claiming B1 was not wearing a legal uniform.

RULING: The protest will be upheld. B1 shall be disqualified for wearing an illegal uniform as the result of removing his shoes. (4-3-1; 4-3-2)

COMMENT: It is not the responsibility of an event judge to caution contestants about adherence to the rules. However, an alert judge would have prevented this situation by informing the jumper about the uniform rule. Even though all other competitors have been eliminated, the competition is not finished until B1 has taken his three trials or decided not to continue.

SITUATION #17: Teammates A1 and A2 are well ahead of the field in the 3200 meter run. (a) A1 keeps speeding up and slowing down allowing A2 to keep pace. (b) A1 tells A2 of his intentions to pace him. The referee overhears this conversation and disqualifies both A1 and A2. The coach of Team A protests the referee's decision on the grounds that the two were well ahead of the field and it did not create an unfair advantage over the other competitors.

RULING: Protest denied. (4-5-8a)

COMMENT: Technically, A2 is committing an unfair act when he slows down and speeds up to pace his teammate A2. Therefore, the referee has the option of disqualification if he/she chooses. When the referee overheard A2's conversation regarding his intention to help A2, he considered that as a blatant violation of Rule 4-5-8, which states it is an unfair act when the competitor has in any way been aided by a coach, teammate, or anyone connected directly or indirectly with the competitor concerned. The question here is not how far ahead of the field the competitors were, but did A2 aid A2.

SITUATION #18: During the high jump competition at the conference meet, A1 leaves the restricted area to confer with her coach between trials and ended up finishing the competition in first place. At the conclusion of the event, the coach of Team C appeals the final results on the grounds that A1 should be disqualified for conferring with her coach outside the restricted area between trials.

RULING: Appeal denied. (4-5-8 Note)

COMMENT: A1 did not commit an unfair act by conferring with her coach, as long as it was outside the restricted area and between trials.

SITUATION #19: The invitational track and field meet has been very tightly contested all day long between Team A and Team C. The score is tied going into the last event, the 4 x 400 m relay. Team C wins the event and is celebrating an apparent championship when the coach of Team A (Team A finished second) protests that C3 wore a watch during her leg of the relay. Upon examination of the arm of C3, the referee discovers a small wrist watch.

RULING: Team C shall be disqualified because C3 was wearing a watch. Team A will be awarded the team championship trophy. (4-5-8f)

COMMENT: Again, the coach, clerk or starter could have prevented this situation had they noticed the watch prior to the competition. In which case the competitor would have been instructed to remove the watch. The referee has no choice, but to disqualify Team C.

SITUATION #20: In the 400 m dash, the runner in lane 7 wishes to set her blocks (a) over to the right side of the lane and when taking her position at the starting line, her right hand is over the outside land boundary, or (b) she sets her blocks at an angle causing the starting block to protrude across the outside boundary.

RULING: This would not be permissible in either (a) or (b), as the runner and starting blocks must be within the contestant's lane. (5-2-3)

1990 NATIONAL FEDERATION BASEBALL RULE INTERPRETATIONS PART II



SITUATION #23: R1 and R2 are (a) between second base and third base or (b) between first base and second base when a throw from the outfield goes into dead ball territory. What are the award?

Ruling: In both (a) and (b) two bases are to be awarded. In (a) this is not a problem, because both runners score. In (b) the lead runner, R1, is entitled to the two base award. R1 is only awarded one base. At no time can a following runner, because of an award, force the lead runner beyond the base allowed according to the maximum award (8-3-3-c).

SITUATION #24: With 7 bases loaded, F6 asks the base umpire how many are out. The umpire indicates that there are two outs. On the next pitch, B5 hits a ground ball to the second base side of F6. F6 fields the ball, steps on the base and rolls the ball to the pitcher's plate. Thinking that was the third out, the defensive team leaves the field, only to be informed by the umpire-in-chief that that was the second out. The coach of the defensive team appeals, claiming that the base umpire misinformed his players concerning the number of outs, which contributed to the opposing team's runs.

Ruling: The defensive team has the responsibility to know how many outs there are. Even though the umpire misinformed the defensive team, the play stands (10-2-3-g).

SITUATION #25: R1 steals second before F2 can make a throw. As R1 brushes himself off, F6 tells him that the ball was hit foul. R1 starts back to first base and is immediately tagged out. R1 claims that F6's comment caused him to be put out and asks the umpire to nullify the out and allow him to remain at second base.

Ruling: R1 has the responsibility to know whether the ball was hit foul or not. Furthermore, R1's base coaches should have kept R1 informed. Therefore, the out stands (10-3-3-g).

SITUATION #26: With R1 on second base, B2 hits a line drive off the shin of F1, causing F5 to change directions in an effort to hold the ball. The change of directions places F6 directly in the path of R1. R1 is unable to avoid running into F5, which causes F5 to misplay the ball.

Ruling: Normally, the runner would be guilty of interference if he made contact with a holder in the process of fielding a ball or attempting a play. In this instance, R1 was unable to alter his base path at the last second, because of the suddenness in which F5 changed directions. Therefore, this is simply considered a collision, the ball remains alive and the play stands (98-3-2, 8-4-2-d).

SITUATION #27: During the game, the visiting team's coach complains to the umpire that the home team is letting its players take batting practice in the batting cage next to the field. The visiting team's coach complains to the umpire that the home team is getting an unfair advantage and that either the home team discontinue batting practice or it share the batting cage with the visiting team.

Ruling: The umpire has no jurisdiction over the use of equipment or facilities outside the confines of the field. This is a matter that must be settled between the two schools. However, if batting practice is taken during the game and the ping-pong sound of the metal bats becomes distracting, the umpire can prohibit further use of the batting cage (10-2-3-g).

SITUATION #28: F1 delivers an inside pitch. As B1 attempts to avoid being hit by the pitch, the ball hits off the handle end of the bat and comes to rest in fair territory. As B1 begins running to first base, the umpire calls "foul ball." B1 stops and starts to return, just as the umpire changes his mind and calls "fair ball." F2 quickly picks up the ball and throws B1 out. B1's coach tells the umpire that he is reversing his call, he placed the batter in jeopardy. The opposing team's coach, who was listening to the conversation, tells his rival coach that the umpire has the prerogative to change his mind, if he thinks he made a mistake.

Ruling: Both coaches are correct. However, an umpire may change his mind so as not to place a batter-runner or base runner in jeopardy. Therefore, the umpire must decide whether or not he thought B1 could have reached first base safely. If in his judgment B1 could have, then he shall be ruled safe. Otherwise, he shall be called out (10-2-3-g).

SITUATION #29: With R1 on first base, R1 is tagged out while (a) being chased by a wasp, (b) being chased by a stray dog, (c) trying to remove an insect from his eye or (d) experiencing a severe muscle cramp.

Ruling: In (a) and (b) the umpire will call "time" to prevent the runner from being tagged out, since the wasp and dog are a threat to the runner's safety. The runner is not protected in (c) and (d), because these are matters that he has control over somewhat. In these instances it is reasonable to assume the runner could request time before leaving the base.

SITUATION #30: Prior to the game, the visiting team's coach notices that the pitcher's mound is a portable or artificial type pitching mound. He consults the umpires.

Ruling: A portable or artificial mound is illegal and shall be removed before the game begins (1-2-1).

SITUATION #31: R1 is on first base, B3 hits a ground ball to F5. R1 is forced at second, but B3 is safe at first base. The coach of the defensive team discovers that B3 was an improper batter and brings it to the umpire's attention.

Ruling: B2 is declared out and returns to first (7-1-2-b).

SITUATION #32: With two strikes on B1, B1 swings and misses a pitch that hits the ground and goes directly into F2's glove. Is B1 out, or can he attempt to advance to first base?

Ruling: Had the ball not touched the ground, B2 would have been out. Since the ball did touch the ground, B2 is entitled to try to advance to first base the same as if the catcher dropped a third strike (7-4-1-b).

SITUATION #33: R1 twists his ankle chasing a fly ball. His coach is granted a time out to attend the injury. At the same time, the assistant coach goes to the mound to visit with the pitcher. Should a charged conference be assessed?

Ruling: No. Since time is already out, the assistant coach is free to have a conference. Likewise, the coach of the team at bat may have a conference with his players. In either case, there is no penalty provided the game is not further delayed. If it is, then a conference should be charged (3-4-1).

SITUATION #34: With (a) one out or (b) two outs and R1 on third, B2 hits a long fly to left field. The third base coach grabs R1 to keep him from advancing in the event F7 catches the fly ball.

Ruling: In (a) and (b) the ball is dead immediately and the runner is called out, because of his coach's interference. In (a) the home run counts. However, in (b) it does not (3-2-2, 9-1-1).

SITUATION #35: With two outs and two strikes on B3, B3 swings and misses a pitch in the dirt. The ball bounces forward off the catcher. B3 hits the ball as he is "unwinding" from his swing. The ball rolls into fair territory, allowing the batter to reach first base safely.

Ruling: The umpire shall call interference and rule accordingly (2-5-3, 7-3-5, 8-4-2-b).

SITUATION #36: On a windy day, with the score tied in the bottom of the seventh inning, two outs, the bases loaded and a full count on B6, B6 tries to check his swing. F7 stands up as the pitch reaches the plate, obstructing the plate umpire's view. The plate umpire asks for help from his partner umpiring at first. The base umpire signals that he did not see it, because dust got in his eyes. As both teams gather for the call around the umpires, one of the spectators, who has been videotaping the game, suggests they look at the video tape and then make the call.

Ruling: The use of video tape to decide the outcome of a play is not allowed. In this case, if the umpires did not see the batter swing, then he "did not". Therefore the play stands (10-1-3 Note).

SITUATION #37: With R1 at first and R2 at second and one out, B4 pops up in the infield. The umpire does not call "infield fly." F5 and F6, trying to catch the ball, bump into each other. The ball rolls away from the fielders. Both runners advance. B4, initially thinking he was supposed to be out because of the infield fly rule, decides to run to first. F6, upon recovering the ball, sees B5 halfway to first and tries to throw him out. The ball goes over the head of F3. R1 and R2 score and B4 ends up at second. The coach of the defensive team informs the umpire that the infield fly rule is in effect. Therefore, B4 should be out and that had the umpire called it like he should have, F6 would not have played on B4, so no runs would have scored. He claims that R1 and R2 should return to the bases they occupied at the time of the pitch.

Ruling: "Infield fly" was not called, so the play stands (2-8-5, 7-4-1).

SITUATION #38: With R1 on first base, B2 hits fly ball to right field. R1 is stealing on the pitch. After touching second, he thinks F9 may catch the ball and in trying to get back to first, does not touch second base. Is the force still on?

Ruling: The force is in effect. Additionally, the defense may throw the ball to second base and put out R1 for not touching the base on the way back to first (2-12-3, 8-2 Penalty).

SITUATION #39: Team A has had three charged conferences by the fifth inning. With the game tied in the sixth inning, the coach of Team A informs the umpire that (a) F6 and F1 are going to trade positions or (b) that S1 is replacing F1. Can the pitcher who is being replaced return to pitch later in the game, or is this considered a charged conference?

Ruling: In (a) and (b) the pitcher being replaced may return to pitch. The umpire shall permit the coach to switch players or substitute, provided the coach does not take advantage of the situation by having a conversation or conference with any of the players. A violation shall result in a charged conference being assessed, which would be more than allowed, resulting in the pitcher not being able to return to pitch (3-1-2 Note).
