The K.H.S.A.A. Salutes the Winners of the Academic Showcase



The sixth annual Sweet 16 Academic Showcase was held in Lexington, Kentucky during the week of the Boys' Sweet 16 Basketball Tournament. Approximately 1,750 students from 209 high schools from 99 counties participated in 12 competitions. Regional competitions were held at colleges and universities around the state in January and February. From these sites the top four place finishers in each competition qualified to come to Lexington to compete for scholarships. The finals in 12 categories were at Transylvania University. The awards were presented on March 15th at a banquet at Marriott's Griffin Gate Resort. A total of \$73,350 in scholarships and prizes was awarded. The showcase is funded by an annual televised auction and donations from private corporations.

MINUTES OF THE BOARD MEETING

March 21, 1991

The Board of Control of the Kentucky High School Athletic Association met in the Capital Plaza Tower, State Board of Education in Frankfort, Kentucky on Thursday, March 21, 1991. The meeting was called to order at 8:30 a.m. by President David Points with all Board members, Commissioner Tom Mills, Executive Assistant Billy Wise, Assistant Commissioners Brigid DeVries and Louis Stout, Sports Information Director Julian Tackett and Earl Cox present. Mr. Harry Loy was present representing the State Department of Education. Sandy Allen offered the invocation.

President Points recognized Dr. Thomas Boysen who came by to welcome the K.H.S.A.A. staff and Board to the State Department. Also in attendance as a visitor was Stan Steidel, newly elected Board member from Dayton High School.

The following actions were taken on the appeals presented by correspondence by Commissioner Mills:

Bob Rogers moved to table, seconded by Eddie Saylor.
Passed.

The next appeal was presented by Ath. Dir. Stan Steidel, Dayton High School who had requested an appeal on behalf of Melissa Hall. Following Mr. Steidel's presentation and questions to him by the Board, Eddie Saylor made a motion to grant Melissa Hall an additional semester of eligibility and allow her to participate in interscholastic athletics. Liz Trabant seconded the motion which passed unanimously.

Bob Rogers made a motion that the minutes of the January 19, 1991 meeting be approved. Huston DeHaven seconded the motion which carried unanimously.

Eddie Saylor moved to approve the minutes of the February 8, 1991 meeting of the East Eligibility Committee. Roland Williams seconded the motion which passed unanimously.

Bob Rogers moved to approve the bills of the Association for the period beginning January 1 and ending February 28, 1991. Harry Jansing seconded the motion which passed unanimously.

Commissioner Mills announced the results of the recent election for new Board of Control members.

Section 2 (Regions 3 & 4):

- Kathy Johnson, Bourbon County High School - 38 votes
- Hopey Newkirk, Bath County High School - 22 votes

Exec. Asst. Wise reported that approximately \$478,000.00 in ticket sales had been received through this date for the Boys State Basketball Tournament with attendance being 130,000 compared to 123,000 for 1990. Advanced ticket sales for the Girls State Basketball Tournament had netted approximately \$24,940.00. He advised the Board that a complete report would be presented at the April Board meeting.

President Points called on Marvin Moore for the Basketball Committee's Report. Following a lengthy discussion with regard to the future status of the Hall of Fame Classic, the Committee recommended that the Hall of Fame Classic be discontinued and that beginning with the 1991-92 school year, each member school be permitted to schedule two extra basketball games for both the boys' and girls' teams. Each school desiring to schedule these additional games would in turn contribute \$150.00 per game to the K.H.S.A.A. Building Fund. Eddie Saylor moved to accept the recommendation of the Basketball Committee with the stipulation that this be an optional opportunity. Harry Jansing seconded the motion. The motion was then amended to direct the All-Sport Committee to draft a plan to be considered by the Board during their April Meeting to permit other sports a similar opportunity to contribute to the success of the Hall of Fame and Museum building program. The motion as amended passed by a vote of 9-2.

Commissioner Mills then discussed with the Board a Modification to Appeals Procedure as presented by Gary Bale, General Counsel for the State Department of Education. Following a discussion of the proposed procedure that would hasten the appeals, Sandy Allen made a motion to accept the procedure. Ray Story seconded the motion which passed unanimously.

A discussion then ensued with regard to a K.H.S.A.A. Position Paper that had been prepared by legal counsel. Roland Williams moved to accept the Position Paper as written. He added that it should be made a part of the K.H.S.A.A. Handbook and mailed to all member schools. Alvis Johnson seconded the motion which passed unanimously.

Commissioner Mills then presented a letter from Greenwood High School requesting that they be moved from the 14th District and be placed in a four-team district in boys' and girls' basketball. Following a discussion of the letter, Alvis Johnson moved to deny Greenwood's request. Bob Rogers seconded the motion which passed unanimously.

Commissioner Mills presented to members of the Board correspondence concerning disciplinary action taken against University Heights Academy for violation of By-Law 27, Requirement for Coaches. He explained that University Heights was required to forfeit twelve (12) regular season basketball games and was placed on probation for two (2) years.

Commissioner Mills distributed material for the National Federal Meeting to be held in San Diego from July 2-6, 1991.

Mr. Wise advised the Board that the next meeting of the Board will be held on April 18 at 1:00 p.m. and the Delegate Assembly will be meeting on April 19. The following committees will also meet:

Exec. Committee - Wednesday, April 17 - 8:30 p.m.

Basketball, Football, and/or All-Sports Committees (if necessary) Thursday morning, April 18

Hall of Fame Committee - Friday - Immediately following the Delegate Assembly Meeting.

All meetings will be held at the K.H.S.A.A. Office.

Ray Story seconded the motion which passed unanimously.

There being no further business, the March 1991 meeting of the Board of Control stood adjourned.

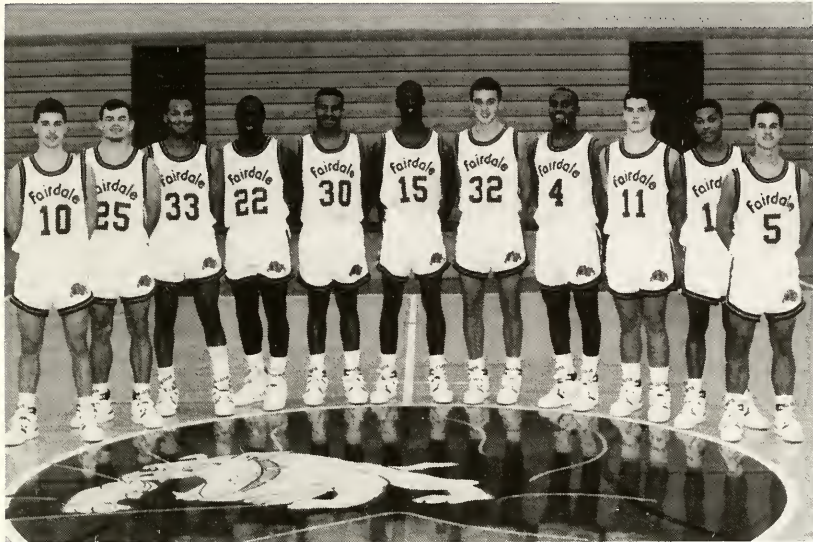

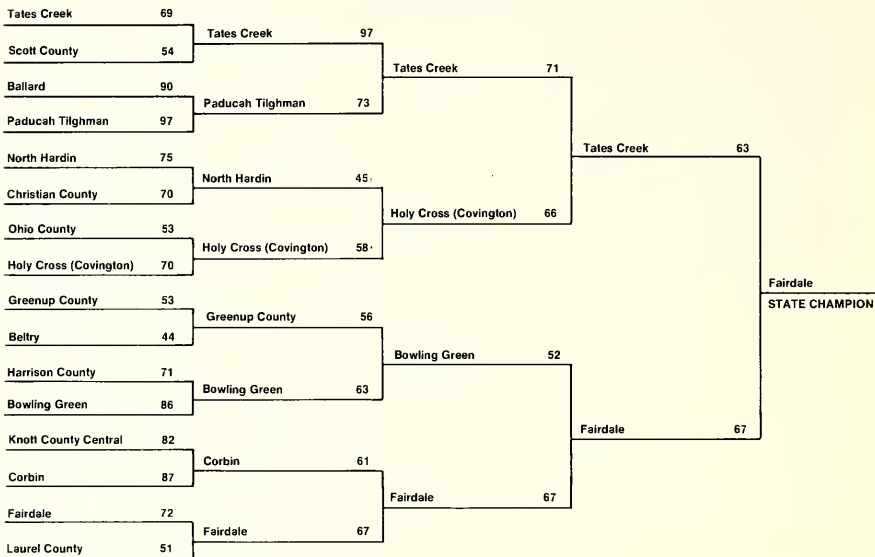

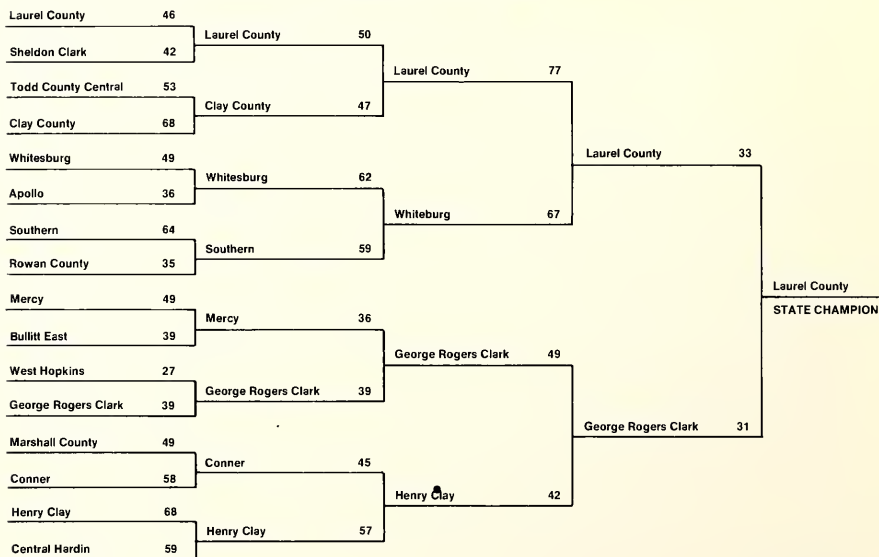

WISE NAMED K.H.S.A.A.'s FOURTH COMMISSIONER

The Board of Control of the Kentucky High School Athletic Association, meeting in regular session on April 18 in Lexington, named Billy V. Wise of Lexington to succeed Tom Mills as Commissioner of the K.H.S.A.A. Wise, a long time Assistant Commissioner with the Association, will take over the day to day duties as Commissioner effective July 1, 1991. Ted Sanford was the Association's first Commissioner, serving from 1947 through 1972 while J.B. Mansfield served from 1972 to 1975.

Mills, who announced his retirement at the March meeting of the Board of Control, will remain with the Association as a Consultant to supervise the construction of the Association's new office building and Hall of Fame/Museum. The building project is now well underway, and is located at 2280 Executive Drive, off Winchester Road near the junctions of Interstates 75 and 64.

Tom Mills first came to the K.H.S.A.A. as a member of the Board of Control in July of 1969 while serving as Superintendent of the Frankfort City Schools. He began his career in public education at Perryville High School in 1958 taking a position as a teacher and coach. He remained there until moving to Stanford High School as Principal in 1960. In 1964, Mills took the Principal's job at Harlan High School before moving to Frankfort High School as Principal in 1965. He held the Principal's position at that school until taking the position of Superintendent in 1968.

He remained on the Board of Control from 1969 until he was hired as an Assistant Commissioner for the Association in 1972. While on the Board, he served as a member of the Board of Control Building Committee which supervised the building of the current Association headquarters on Cooper Drive. In 1975, Mills was named Commissioner of the Association.

During Mills' tenure as Commissioner, the Association has seen tremendous growth in both the depth and scope of the activities. Many sports have been added, as well as the increases in attendance, and therefore, financial assistance, from the Boys' and Girls' Basketball tournaments. In 1988, with the help of retired Courier Journal columnist Earl Cox, Mills was instrumental in the forming of the Dawahares Kentucky High School Athletic Association Hall of Fame, which now has 87 members.

A graduate of Pineville High School, Mills attended Eastern Kentucky University where he received his B.A., M.A. and Rank I Certification. He has served on a myriad of community and civic clubs and activities including the Board of Directors of the Kentucky Mountain Laurel Festival, the National Federation Executive Committee including a year as Vice-President, the Chairman of the National Federation Fund Administrators Association Insurance Committee, the National Federation Football Rules Committee, and as Vice President and President of the EKU Alumni Association.

Commissioner Mills is married to the former Betty Howard of Pineville, a retired school teacher. The Mills have four children – Tommy, currently the Principal at Boyle County High School, Randy, Associate Director of Admissions at the University of Kentucky, Jennifer Mills Andes, a teacher in the Scott County School System, and David, a senior at Eastern Kentucky University.

Mills' replacement, Billy Wise, has been with the K.H.S.A.A. since August of 1969. First named Assistant Commissioner in 1969, Wise was named Executive Assistant in 1981 to handle the affairs of the office in the absence of the Commissioner.

A graduate of Stamping Ground High School, and Transylvania University, Wise also attended Campbellsville College, and did graduate study in the Masters of Education program at the University of Kentucky. He has been the Association's interpreter for Football and Basketball rules throughout his tenure at the K.H.S.A.A., and has conducted the annual rules clinics in those sports during that time.

Wise is a former contest official, having refereed one year of professional football in the Continental League, 5 years in both the Southeastern and Ohio Valley Conferences in basketball, 14 years in the Kentucky Intercollegiate Conference in basketball, and 18 years as a high school official prior to his tenure at the K.H.S.A.A.

A veteran of the United States Army during the Korean conflict, Wise is married to the former Bonnie Goodan, and the couple has two sons, Steve of Lexington, and Gary who resides in Louisville, and a daughter, Missy Wise Renner, of Lexington.

The Board of Control is currently taking applications for the position of Assistant Commissioner, with requirements including a Kentucky teaching certificate. Applicants possessing administrative experience and an advanced degree are preferred. Interested parties should contact the Association in Lexington for application information.

The Board of Control is also taking applications for the position of Sports Information Director. This position became vacant when Julian Tackett, the Associations' S.I.D. since 1984, was promoted to Director of Business Affairs by the Board, also at the April meeting of the Board of Control.

SPECIAL NOTE ON CORRESPONDING DATES

Earlier in the year, Athletic Directors were mailed a proposed corresponding date calendar, which was adopted in concept by the Board of Control at its January meeting. The release of this calendar has caused some confusion.

THE DATES OF THE 1991 CHAMPIONSHIPS ARE AS PRINTED ON THE MEMORANDUM CALENDAR. The dates under the 1990-91 column on the corresponding date chart were included only for reference as corresponding dates for scheduling. The calendar is in the process of being finalized, and the final document will be mailed to member school athletic directors in the next few weeks.

MEMBER SCHOOLS ALERTED TO CHANGE IN SEASONS

Please note the above reference scheduled which was sent earlier this year when making your game contracts for 1991-92.

In addition, a report was printed in several newspapers concerning the Hall of Fame basketball, football and all sports contests which can be played. The Board of Control has approved IN CONCEPT a plan which would allow all schools to help in the fund raising for the Hall of Fame and Museum.

Member school principals will be notified when this proposal is finalized, and you will have sufficient time to schedule games when that notification is mailed.

UNIVERSITY OF KENTUCKY TO OFFER COURSE IN FOOTBALL COACHING AND OFFICIATING

The University of Kentucky will conduct a four week course starting May 7 entitled "Football Coaching and Officiating". This course will emphasize planning and implementing a program in football coaching and officiating. The course will be offered weekdays from 4:00 to 6:00. REMINDER TO SCHOOLS CONCERNING LIMITATION OF SEASONS

All schools are reminded of the Limitation of Seasons Rules, K.H.S.A.A. By-Law 27, as it applies to competition after the conclusion of the regular season. ALL SPORTS are affected by this rule, which states that following the teams' last regular season match, there shall be no further practice or play as a team for the remainder of the school year, with the exception of the K.H.S.A.A. tournament. Please be sure your coaches are aware of this important rule, and that they are not involved in coaching the team in an outside league, or other competition. For the high school coach, be they the Head Coach or an assistant coach, to coach members of the high school team in a league outside of the school's legal regular season competition, regardless of the type of league, would be a violation of the rules governing the Limitation of Seasons.

The first level features the popular Spalding Shoot-Out where fans can try their skill at scoring baskets at different heights, and the Gift Shop.

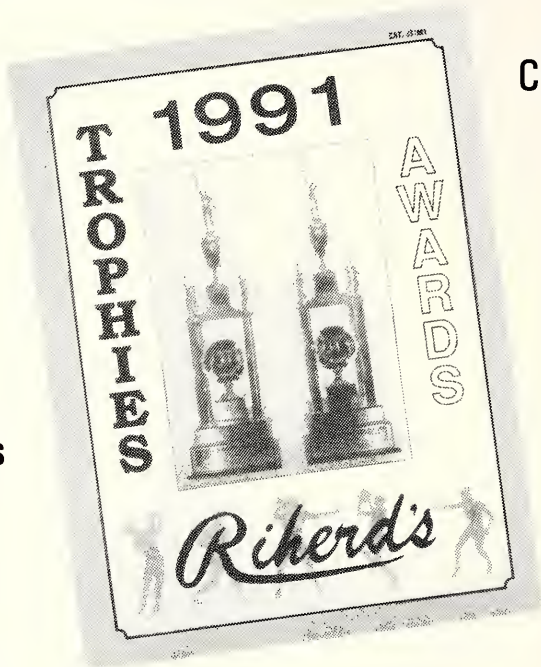
