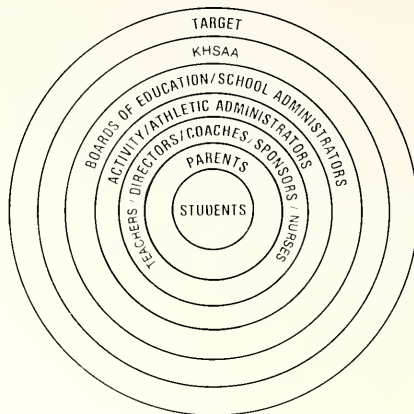

Earlier in the year, Athletic Directors were mailed a proposed corresponding date calendar, which was adopted in concept by the Board of Control at its January meeting. The release of this calendar has caused some confusion.

THE DATES OF THE 1991 CHAMPIONSHIPS ARE AS PRINTED ON THE MEMORANDUM CALENDAR. The dates under the 1990-91 column on the corresponding date chart were included only for reference as corresponding dates for scheduling. The calendar is in the process of being finalized, and the final document will be mailed to member school athletic directors after the state basketball tournaments.

SPECIAL NOTE CONCERNING UNIFORMS

Normally, uniform decorations such as flags, etc., are not permitted on the game jersey, but may be worn on the uniform shorts or warm-ups. However, effective 1/24/91 and for the duration of the Gulf War or the end of the school year, the National Federation has adopted a policy which allows the official flag of the U.S. to be worn on the game uniform. The flag is to be no closer than 2" to any player's number, and may not be located between dual numbers. This policy will be in effect through the duration of the war, or the end of this school year, and supersedes any previous memorandums or interpretations. Please contact the Association office if you have any questions.

REMINDER TO SCHOOLS CONCERNING LIMITATION OF SEASONS

All schools are reminded of the Limitation of Seasons Rules, K.H.S.A.A. By-Law 27, as it applies to competition after the conclusion of the regular season. ALL SPORTS are affected by this rule, which states that following the teams' last regular season match, there shall be no further practice or play as a team for the remainder of the school year, with the exception of the K.H.S.A.A. tournament. Please be sure your coaches are aware of this important rule, and that they are not involved in coaching the team in an outside league, or other competition. For the high school coach, be they the Head Coach or an assistant coach, to coach members of the high school team in a league outside of the school's legal regular season competition, regardless of the type of league, would be a violation of the rules governing the Limitation of Seasons.

1991 ANNUAL MEETING OF THE DELEGATE ASSEMBLY

The Business meeting of the Delegate Assembly of the Kentucky High School Athletic Association will be held on Friday, April 19, 1991 at 11:00 a.m. at the K.H.S.A.A. Office Building, 560 East Cooper Drive, Lexington, Kentucky.

As provided in Article IX, Section 1, of the K.H.S.A.A. Constitution, the following proposals for changes in the rules of the Association, to be acted upon at the annual meeting, are hereby submitted to all members of the K.H.S.A.A. for their information. No proposals other than these may be considered at the Annual Meeting, except by a two-thirds vote of the delegates.

PROPOSAL I

Principal Peter Flaig, Trinity High School proposes that the following amendment be made to By-Law 25.

3. Cross Country:
 - (3) Change "... prior to September 1" to "... prior to ten (10) weekends prior to the weekend of the Regional Meet."
12. Wrestling:
 - Change "... prior to December 1" to "... prior to nine (9) weekends prior to the weekend of the District Tournament.

PROPOSAL II

Principal George Johns of Dayton High School proposes that the following changes be made in the Constitution of the Kentucky High School Athletic Association.

Article IV: Administration And Legislation

Section 1 - Officers (Be changed to read:)

The officers of the Association shall be a Commissioner and a Board of Control composed of Twenty-four members, (24) at least four (4) of whom shall be black and four (4) of whom shall be female.

Section 2 - Procedures of Election & Board of Control (shall be changed to read:)

B. Board of Control

1. Members of the Board of Control shall be elected for a period of four (4) years by a vote of the representatives of member schools in each region.
2. There shall be one (1) member from each of the sixteen (16) Basketball Regions.
3. In addition there shall be four (4) blacks and four (4) females elected (Federal Court Decree), two (2) blacks shall be elected to represent Regions 1 through 8 and two (2) blacks shall be elected to represent Regions 9 through 16. Two (2) females shall be elected to represent Regions 1 through 8 and two (2) females shall be elected to represent Regions 9 through 16.
4. All Board of Control members shall be full-time certified employees of their respective Boards of Education.
5. Notifications to the **Representatives** of each school in each **Region**, in which the member is to be elected must be made by the Commissioner not later than January 1.
6. To be eligible for membership to the Board of Control, one must be a certified employee of an accredited K.H.S.A.A. member school or system in the region he/she is to represent and must remain in that region during his/her term of office. Serving in a part-time capacity or on leave of absence or on sick leave in any of these capacities will terminate the eligibility of the member and the remaining members of the Board shall fill the vacancy within sixty (60) days in the same manner as that prescribed for the regular election of the Board Members.
7. Nominations for membership on the Board of Control, signed by five (5) representatives of their **region**, shall be

in the hands of the Commissioner, for **regions** that elect during the year, not later than midnight January 31.

8. Ballots for election shall be distributed by the Commissioner before February 15, and returned on or before March 1.
9. Results of the election shall be tabulated by the Commissioner, announced at the meeting of the Delegate Assembly, and published in the May issue of the "Athlete."
10. Terms of Board Members shall be staggered so that six (6) will be elected each year.
11. At the Organization Meeting in July, the members of the Board of Control shall elect from their membership a President and Vice-President to serve for one (1) year. They shall not be eligible to serve for more than two (2) one-year terms in succession. The Superintendent of Public Instruction shall designate a liaison person to meet with the Board of Control to participate in all discussion but to have no vote as a member of the Board of Control.

PROPOSAL III

Principal Kenneth W. Frick, Butler High School proposes that the Article IX, Section 4, be changed to read:

- b. Board of Control - Members of the Board of Control shall be elected for a period of four years by vote of the representatives of member schools in each section (Basketball Regions 1 & 2, 3 & 4, 5 & 6, 7 & 8, 9 & 10, 11 & 12, 13 & 14, 15 & 16) and shall be a **high school principal**.

PROPOSAL IV

Principal Edward Driscoll, St. Xavier High School, proposes the following change to By-Law 25, Limitation of Seasons:

9. Tennis - Boys and Girls

BE IT RESOLVED that the tennis season allow for 25 dual matches and four tournaments, each counting as one match.

PROPOSAL V

The Board of Control of the Kentucky High School Athletic Association proposes that the following Articles be presented for consideration:

- 1) Article IV, Section 2,(b) be amended to read as follows:
... of office. Serving in a part-time capacity or on leave of absence (exclusive of employee earned sick days) will terminate ...
- 2) Article IV, Section 2,(b) be amended to read as follows:
... represent, and must remain employed in that region during his or her tenure of office.
- 3) Article IV, Section 3, (c.8) be amended to read as follows:
Arrange a series of baseball, basketball, football and wrestling rules interpretation clinics before the beginning of the respective seasons.
- 4) By-Law 25, Section 11.(5) shall be amended to read as follows:
The regular season ends at the conclusion of the varsity team's last regular season match, with the exception that the varsity team may play until its elimination from K.H.S.A.A. sanctioned tournament play.
- 5) By-Law 26 be amended as follows:
Remove section 2, 4, 6, and 9. Renumber all other sections and add Section 7 to read, All officials registered with the K.H.S.A.A. shall be governed by the Officials Guidebook, published annually by the Association.
- 6) By-Law 27, Section 3, be amended as follows:
... soccer, softball, volleyball and wrestling shall attend the annual ... sponsored rules clinic ... Track officials shall attend bi-annually.

Rule Book

Page 79 - The diagram shows the vaulting '0' point running through the bottom of the planting box or stopboard. However, since rule 7-4-13 specifically designates the top of the planting box as the '0' point, measurements will continue to be made from the top of the stopboard as in past years.

SITUATION #1: As the competition is coming to a close in the preliminary round of the discus event, the event judge notices that one of the competitors is wearing a watch during his trial. Upon further investigation, the event judge discovers that the competitor had worn the watch in his earlier trial as well.

RULING: The competitor would be disqualified from the event. Furthermore, if he had qualified for the finals, the next best thrower would be moved up to the finals.

COMMENT: Up to 1991, competitors have been permitted to wear a watch while competing in the field events, but it has been considered an illegal aid when wearing a watch while competing in a running event. Sometimes athletes would forget to remove the watch when going from a field event to participate in a running event or were confused as to when they were permitted to wear a watch, which has resulted in some unfortunate disqualifications. To be consistent and to eliminate confusion, track and field athletes will not be permitted to wear a watch while competing in any event. (4-5-9f)

SITUATION #2: Prior to the start of the 3200 m run, A1's coach asks the referee to permit A1, who is an asthmatic, to use an atomizer containing a prescription drug designed to alleviate the asthmatic condition.

RULING: If A1's condition is verified by a physician and the doctor has prescribed this medication, it would not be considered an illegal aid as long as a physician's statement documenting the need of the athlete to use a prescription is presented to the meet director prior to the start of the competition situation 4-5-9c.

COMMENT: Since the asthmatic athlete is at a disadvantage because of his/her condition, the rules committee feels that the use of a prescribed atomizer would not give the asthmatic competitor an unfair advantage and has approved the use of the atomizers as long as they are prescribed by a physician. A letter or note from the doctor must be presented to the meet director/referee documenting the need of the athlete to use the atomizer to ensure his/her safety.

SITUATION #3: Following the finals of the 300 m intermediate hurdles, A1 and B1 complain that the third hurdle in their lanes were set higher than the standard 36". After checking the height of the hurdles in question, the referee discovers they were incorrectly set at 39" and all other hurdles were at the 36" height. A1 finished first, while B1 finishes fourth.

RULING: It is within the referees authority to declare A1 the winner and after an appropriate amount of rest rerun the race involving the remaining competitors.

COMMENT: When a race is rerun, it may not be necessary to have all contestants participate in the rerun if the runner was not involved in the situation causing the rerun, and has clearly earned the place awarded by meet officials. However, as in the above situation, A1 may participate in the rerun in an attempt to better his time for record purposes. If that would be the case, he would also jeopardize losing his present standing.

SITUATION #4: In the shot put, A1 who is very heavy set, reports to the event wearing sweat pants and a jersey that appears to be a football practice jersey. The coach explains that the school does not have a jersey and shorts that would fit A1, and requests permission of the event judge for A1 to compete as he is dressed.

RULING: Since A1 does not comply with rule 4-3-3, the request is denied.

COMMENT A: While the rules committee sympathizes with the coach and athlete in this situation, it is the responsibility of the school to make every effort to provide the same uniform for all members of its track team. Even if the uniform is on order and it will take some time to process, the school can provide a jersey and shorts which are close to the same color and style as the other teammates. Situation 4-3-3 has been deleted from the Case Book.

COMMENT B: Playing rules written for high school competition have consistently stipulated the exclusive wearing of school uniforms. Even though track and field consists primarily of individual events, it is still a team sport. School-sponsored activities should not provide for individual costumes that deviate from the color and style of the uniforms worn by all members of the high school team.

SITUATION #5: The terms and conditions of conference dual competition stipulates that when the host school has qualifiers for 4 lanes only, each school may enter only two hurdlers in the first heat and the first two finishers will receive first and second places. The remaining hurdlers will be entered in the second heat and the winner of this heat will be awarded third place with no opportunity to finish higher than third place.

RULING: In the above situation, the host school may run the hurdle events in two timed heats. However, the slower runners should be placed in the first section and the faster runners in the second section. All competitors should be timed and individual places determined by the faster times of all competitors. Conferences or leagues may adopt a more restrictive standard, but may not adopt a more permissive standard than provided by National Federation Rule.

SITUATION #6: At the conclusion of the 4 x 400 relay it is discovered that competitor B3 has competed in 5 events: the 4 x 100 relay, the 100 meters, the 400 meters and the high jump.

RULING: B3 shall be disqualified from further participation and shall forfeit all places, team points and medals earned in all events. Also, the 4 x 100 and 4 x 400 relay teams shall forfeit all places, team points and medals earned. Lower place winners in each event will be advanced.

SITUATION #7: After an unsuccessful trial at 6'4", A1 is excused to compete in the first heat of the high hurdle prelims. Due to interference, the referee orders the race to be rerun following the third heat. Due to the rerun, A1 reports back to the high jump 20 minutes after being excused, and the bar is now raised to 6'6".

RULING: A1 will be permitted two trial at the new height. (7-2-7)

COMMENT A: When A1 failed to return within the limit, the event judge may consider A1's remaining attempts as passed trials and proceed with competition among the other entries, including the raising of the crossbar when all other competitors have cleared, failed or passed the preceding height.

COMMENT B: Guidelines for a competitor who has been excused from a field event to compete in another event include:

- (a) The athlete must receive permission from the event judge;
- (b) The judge must record the time excused;
- (c) The judge may allow the competitor to take a trial out of turn before being excused;
- (d) The judge will use some judgment in extending the time excused under special circumstances, e.g. 3200 m run;

(e) In the high jump and pole vault, if the competitor has failed to return in the allotted time and all other remaining competitors have either passed, failed or cleared the existing height, the crossbar will be raised to the next height and the judge will automatically pass the excused competitor to the new height.

(f) Coaches must take into account the limited time allowed to compete in another event when determining the events any individual competitor enters.

(g) When an unusual circumstance (injury, rerun, etc.) occurs that will prolong the absence of the excused participant, it shall be the participants responsibility to communicate this to the event judge.

SITUATION #8: Team A reports to the clerk of the course for the 4 x 100 relay and when they take off their warm-ups, the clerk notices that runner #1 is wearing a white T-shirt over a blue turtle neck under the traditional track jersey, runner #2 is wearing a white T-shirt under her jersey, runner #3 is also wearing a white T-shirt under the track jersey, and runner #4 is wearing a blue turtle neck under her jersey. The clerk informs the relay team that their uniform is illegal in that multiple colors are showing under the traditional track jersey and asks the girls to remove the undergarments so only one color is showing under the jersey. Team A's coach appeals the ruling by the clerk.

RULING: The appeal shall be denied.

COMMENT: Rule 4-3-1 stipulates that any apparel that is worn in excess of the school uniform, must be worn under the school-issued jersey or shorts, and if visible is restricted to a single (solid) color (minus any trim of a second color). When undergarments are worn by more than one member of a relay team, those undergarments must be the same color. Layering is permitted, as long as only one color is visible (example: white T-shirt over a white turtle neck). In the above situation, the girls 4 x 100 relay team must choose between white or blue but may not use both colors.

SITUATION #9: In dual competition, B1 reports to the 400 m dash wearing red thigh huggers over black leotards under his tradition blue track shorts and B2 is wearing black bicycle lights under his track shorts. The starter informs B1 he is wearing an illegal uniform and informs him that he cannot participate until he changes his attire so that only one color is showing beneath his track shorts. B1's coach protests, pointing out that both undergarments are a single (solid) color which he feels meets the rule.

RULING: The protest is denied.

COMMENT: It has been established that undergarments are permissible in track and field. However, it has been clarified that the undergarment must be of a single (solid) color and minus of any trim, and if more than one undergarment is worn under the short, each undergarment shall be the same color. If both undergarments are of a different color, then only one undergarment may be visible.
