Active coaches must be 60 years of age or older. Inactive coaches under the age of 60 must have been inactive for three years to qualify.</p> <p><u>Nominations</u> Anyone can nominate a person for the Hall of Fame. Nomination deadline is April 1. An official KHSAA Hall of Fame nomination form must be completed for each nominee. Additional information can also be submitted with the nomination form.</p> <p><u>Selection</u> The number of inductees to be selected begins with 18 in 1995 and decreases by one each year until the maximum number of 12 is reached. MINUTES

DECEMBER 2, 1994

The Board of Control of the Kentucky High School Athletic Association met at the Executive Inn, Louisville, Ky. on Friday, Dec. 2, 1994. The meeting was called to order by President Frank Cardwell at 8 a.m. with all Board members present except Bill Beasley and Tom Bryant. Also present were Commissioner Louis Stout, Assistant Commissioners Brigid DeVries and Larry Boucher, Bus. Mgr. Julian Tackett, SID Brooks Downing, Ken Tippett, Board Attorney Danny Reeves and Randy Kimbrough, State Dept. of Education. The Invocation was given by Alvis Johnson.

Frank Welch made a motion, seconded by Ozz Jackson, that the minutes of the Oct. 15-16, 1994, meeting of the Board be approved. The motion passed unanimously.

Tasso Harris made a motion to approve the October 10 East Eligibility Committee Minutes. Wendell Thomas seconded the motion which passed unanimously.

Following questions regarding bills from Sept 1 through Oct. 31, 1994, Frank Welch made a motion to accept. Ken Cox seconded the motion which passed unanimously.

A discussion was held regarding the 1994-95 Working Budget through Oct. 31. Wendell Thomas made a motion to accept. Tasso Harris seconded the motion which passed unanimously.

Frank Welch moved to approve the East Eligibility Committee Minutes of Nov. 28. Cookie Henson seconded the motion which passed unanimously.

Minutes of the Dec. 1 West Eligibility Committee will be presented for approval at the Jan. 20 Meeting of the Board.

President Cardwell called on Doug Ralston to present his appeal of Bylaw 6 on behalf of his son, Ryan. Mr. Ralston's case was heard by the East Eligibility Committee on Oct. 10; however, the vote of the Committee was 4-2 and did not receive the necessary five votes for a ruling. Prior to his appeal, Mr. Cardwell explained to the appellant the procedure for presentation. Mr. Ralston was allowed to present his case and distribute to the Board any additional information relative to the case. After his presentation, the Board went into Executive Session. Following return to Open Session, a motion was made by Ozz Jackson to grant the appeal of Ryan Ralston. Teresa Isaac seconded the motion which passed by a roll call vote of 9-5.

The next regular Board of Control meeting is scheduled for March 23-24, 1995, at the Girls' Sweet 16 in Frankfort.

Following the appeal and the reinstatement of eligibility, Mr. Harris expressed a concern regarding the immediate participation for athletes reinstated by the Board in all sports except football where ten (10) practices were required prior to play. The Board discussed at length the procedure for submitting proposals to the Delegate Assembly and suggested this concern could be addressed. Mr. Cardwell announced that the proposals which were submitted for the Delegate Assembly were on the Agenda for approval.

Following a lengthy discussion of Slow Pitch/Fast Pitch Softball alignments which were distributed for discussion only, Claudia Hicks made a motion that the Board set a minimum number of games in Slow Pitch/Fast Pitch Softball as ten (10) to qualify to play in postseason, and that schools must declare by Feb. 1 if they will play SP/FP Softball. Ken Cox seconded the motion which passed 9-5. Bob Rogers then made a motion that Fast Pitch Softball Officials be paid \$20.00 per game and a limit of one and one half (1-1/2) hours per game be set. The motion passed unanimously.

Darrell Treece then made a motion that the KHSAA Staff set the clinics for coaches for Fast Pitch Softball in compliance with current bylaws. Tasso Harris seconded the motion which passed 13-1.

A discussion then ensued regarding the starting dates for spring sports for 1994-95. Stan Steidel made a motion, seconded by Grant Talbott, that all spring sports may begin on March 25 for the 1995 season only. The motion passed unanimously.

The Board then considered a request from Carroll County High School to waive Bylaw 27, Requirement for Coaches, for one year. Following discussion, Tasso Harris made a motion to waive Bylaw 27 for Carroll County High School. Darrell Treece seconded the motion which passed unanimously.

Following a brief discussion of district and regional basketball officials' assignments, Tasso Harris made a motion to table the recommendation presented until the January meeting in order to obtain input from the schools. Stan Steidel seconded the motion which passed.

President Cardwell called a recess until 8 a.m. on Saturday, Dec. 3.

DECEMBER 3, 1994

President Cardwell reconvened the Board meeting at 8 a.m. on Saturday, Dec. 3, 1994. All Board members were present with the exception of Bill Beasley, Tom Bryant and Teresa Isaac. Also present were Commissioner Louis Stout, Assistant Commissioners Brigid DeVries and Larry Boucher, Bus. Mgr. Julian Tackett, SID Brooks Downing, Ken Tippett and Anne Wesley Mays, Secretary. Randy Kimbrough, State Dept. of Education, was also in attendance.

Commissioner Stout advised the Board of the disposition of appeals heard by the SBESE -- 8 cases upheld and 7 cases overturned.

Commissioner Stout then recommended the following dates for the Boys' and Girls' State Basketball Tournaments for 1996 through 1999:

Grant Talbott made a motion, seconded by Claudia Hicks, to accept the Commissioner's recommendation. The motion passed unanimously.

The Commissioner reported that advanced ticket sales for the Boys' Basketball Tournament were nearing \$400,000. He also asked for input from the Board members on various regional basketball tournament sites. Mr. Stout gave an update on plans that are being coordinated by Lexington leaders for the "Sweet 16" Fan Jam to be held in conjunction with the Boys' Basketball Tournament at Heritage Hall.

Following a discussion of Commissioner Stout's report regarding the guidelines set forth for the KHSAA Hearing Officer, Bob Rogers made a motion to approve and move on as soon as possible with the recommendation. Tasso Harris seconded the motion, which passed unanimously.

Items of discussion with no action taken were 1) Doug Ruedinger, Inc.; 2) KHSAA Strategic Plan; 3) Topics for Seminars to be conducted in conjunction with the Annual Meeting in February; 4) State VB Tournament Team Expense policy; 5) Auditor's letter; 6) Progress of appointees to the Middle School, Cheerleading, Summer Play and Insurance Committees.

The Board was advised that a large number of schools had not submitted names for their Delegate to the Annual Meeting by the Nov. 15 deadline. Tasso

Harris made a motion, seconded by Claudia Hicks, that due to the change in the KHSAA Constitution, those schools be notified again and extend the deadline to Dec. 15, 1994. The motion passed unanimously.

Bus. Mgr. Tackett advised the Board that the Hotline for reporting KHSAA violations had been established as recommended by the Task Force on Interscholastic Athletics and requested approval of the news announcement and regulations as submitted. Ozz Jackson made a motion to accept the document as presented. Wendell Thomas seconded the motion which passed unanimously.

Following a discussion of the final adoption of the Fine Schedule in accordance with Bylaw 30, Tasso Harris made a motion to approve the Schedule of Fines after deleting and/or Board of Control. Wendell Thomas seconded the motion which passed unanimously.

The next item on the Agenda was the Football Committee's Report presented by Chairman Ozz Jackson. He made a motion that the Board accept the following changes to the Tournament Rules for Football:

I. C. CLASSIFICATION

d. . . to fall below (4) or exceed eight (8) teams.

e. If at any time during the classification period, a school withdraws from play-off competition, it shall not be eligible for two (2) seasons and may return to competition in the odd-numbered year following the two-year period.

II. Dates and Times for Play-off Games

A.3. In Class AAAA, Regions II and III, the Region II, District 1 teams will play the Region II, District 2 teams in 1995 and quadrennially (every four years) thereafter for the Region II championship. Also, in 1995 and quadrennially (every four years) thereafter, the Region III, District 1 teams will play the Region III, District 2 teams for the Region III championship.

In Class AAAA, Regions II and III, the Region II, District 1 teams will play the Region III, District 1 teams in 1996 and quadrennially (every four years) thereafter for the Region III championship. Also, in 1996 and quadrennially (every four years) thereafter, the Region II, District 2 teams will play the Region III, District 2 teams for the Region II championship.

In Class AAAA, Regions II and III, the Region II, District 1 teams will play the Region II, District 2 teams in 1997 and quadrennially (every four years) thereafter for the Region III championship. Also, in 1997 and quadrennially (every four years) thereafter, the Region III, District 1 teams will play the Region III, District 2 teams for the Region II championship.

In Class AAAA, Regions II and III, the

Region II, District 1 teams will play the Region III, District 2 teams in 1998 and quadrennially (every four years) thereafter for the Region III championship. Also, in 1998 and quadrennially (every four years) thereafter, the Region II, District 2 teams will play the Region III, District 1 teams for the Region II championship.

Grant Talbott seconded the motion which passed 12-1.

The following persons then addressed the Board with their school's concern in response to the proposed football alignment:

Tasso Harris made a motion that the Board consider one Class at a time. Ken Cox seconded the motion which passed unanimously.

Class A: Tasso Harris moved to accept Class A alignment as printed on the draft. Grant Talbott seconded the motion which passed unanimously.

Class AA: Tasso Harris moved to accept Class AA alignment as printed on the draft. Bob Rogers seconded the motion which passed unanimously.

Class AAA: Tasso Harris moved to accept Class AAA alignment as printed with the following exceptions: move Johnson Central to Region 4, District 2 and Marion County to Region 2, District 1. Claudia Hicks seconded the motion which passed unanimously.

Class AAAA: Tasso Harris moved to accept Class AAAA alignment as printed with the following exception: move

Lafayette to Region 4, District 2 and George Rogers Clark to Region 4, District 1. Ken Cox seconded the motion which passed by a roll call vote of 10-3.

The next item on the Agenda was the consideration of Proposals for the Annual Meeting. The Board discussed options for addressing the Proposals which were submitted. Stan Steidel then made a motion that the Board send a Proposal to the State Board requesting clarification of the word "sponsor" as it appears in HB 490, and KHSAA Bylaw 40. Girls' Basketball Tournament, Girls' Fast Pitch Softball. Cookie Henson seconded the motion which failed by a roll call vote of 6 to 7.

Ms. Hicks made a motion that the State Volleyball and State Soccer Tournament dates be set and then count back 8 weeks for the start of the seasons. Tasso Harris seconded the motion which passed unanimously.

Mr. Tackett announced the next meeting of the Board has been scheduled for January 19-20, 1995 at the KHSAA Office in Lexington. Appeals will be heard on the 19th with the Regular meeting to follow on the 20th.

Ms. Hopper called a meeting of the Constitution & Bylaws Committee immediately following the present Board meeting.

Ms. Kimbrough, as State Board of Education liaison, advised the Board of items being considered by Site Based Councils in the local districts.

There being no further business to come before the Board, Ozz Jackson made a motion to adjourn. Grant Talbott seconded the motion which passed.

West Eligibility Committee

MINUTES

DECEMBER 1, 1994

The West Eligibility Committee of the KHSAA Board of Control met in Louisville at the Executive Inn on Thursday, Dec. 1, 1994, for the purpose of hearing eligibility appeals. Frank Cardwell called the meeting to order at 10 a.m. Members present were Tasso Harris, Kathy Hopper, Bob Rogers, Grant Talbott and Wendell Thomas. Members absent were Bill Beasley and Darell Treece. Others present were Commissioner Louis Stout, Asst. Commissioners Brigid DeVries and Larry Boucher, Julian Tackett, Bus. Mgr., Arny Wesley Mays, Administrative Secretary, Randy Kimbrough of the State Department of Education and Danny

Reeves, Board Attorney.

Prior to each appeal, Mr. Cardwell explained to the appellant the procedure for presentation. Each party was allowed to present his/her case and distribute to the Board any additional information relative to the case. After each presentation, the Board went into Executive Session. Following return to Open Session a motion was made to either grant or deny the appeal. A roll call vote was taken by the Secretary. The appellants were advised of the decision of the Board and Mr. Cardwell explained the Due Process Procedure in the event the appeal was denied. It was determined that five (5) affirmative votes were needed to pass a motion or restore eligibility.

1995 Delegate Assembly Proposals

Proposal 1

George Frakes, principal of Highlands High School, proposes the following amendment to the bylaws of the Kentucky High School Athletic Association. An amendment to clarify the ending of the school year for summer play purposes to alleviate the inconsistencies caused by various schools ending on different dates, and weather-related problems.

Bylaw 8. Contestant On Other Teams, Post Season and All-Star Games

Any student who is a contestant in football or basketball on any non-school sponsored team in that sport at any time during an athletic season after enrolling in grade nine (9) shall be ineligible to represent any secondary school in that sport for the remainder of that season or for the upcoming season.

A student who has been a first-team player in football or basketball after enrolling in grade nine (9) and has eligibility remaining in these sports shall not take part in an all-star or postseason game in that sport during the remainder of the school year prior to May 25 of the school year unless it has been sanctioned by the Board of Control. The penalty shall be loss of eligibility for one year. The Commissioner may waive the period of ineligibility if just cause is shown as to its application working evident injustice against the student-athlete.

Rationale - Many districts set different dates for the respective school calendars due to local concerns, transportation, and weather-related circumstances. This amendment would allow for a benchmark date to be fair to all participants throughout the state in spite of differing school calendars.

Proposal 2

Steve Fommeyer, delegate representing Eminence High School, proposes the following amendment to the bylaws of the Kentucky High School Athletic Association - An amendment to allow football teams not competing in district championship play to play an additional football game to create a "playoff" for those schools.

Bylaw 25, Limitation of Seasons

4. Football - Boys

(4) A maximum of ten (10) regular season games may be played. Preseason bowl games shall count toward the 10-game limit. Schools not competing for the district title may play an eleventh (11th) game to be played not later than three weeks prior to the final championship game. (5) The regular season ends at all levels of play (grades 9-12) on the Saturday preceding the first KHSAA Tourna-

ment (District, Region or State), with the exception of the special circumstances for teams not competing for district play as detailed in subsection (4) above, and that the varsity team may practice and play through its elimination from KHSAA sanctioned tournament play. Following elimination, there shall be no further practice or play during the remainder of the academic school year.

Proposal III

Principal Janice Fish of Atherton proposes the following amendment to the bylaws of the Kentucky High School Athletic Association - An amendment to allow for an additional tournament to be played in volleyball to encourage more play on weekends and less impact on school-night activities.

Bylaw 25, Limitation of Seasons

11. Volleyball - Girls

(4) The season shall consist of a maximum of twenty (20) matches. In any ~~two (2)~~ three (3) invitational or other type tournaments, the matches played by a member school shall count as only one match for each tournament.

Rationale - With various formats of tournaments now being played, many schools may inadvertently be violating tournament limits without missing additional school time. In addition, the author and the State Volleyball Committee have concerns that this girls' sport offering can be better promoted with this change and it will lessen school study time by playing on weekends.

Proposal IV

Board appointed representative Stan Steidel of Dayton High School proposes the following amendment to the Constitution of the Kentucky High School Athletic Association - An amendment to further clarify the eligibility of an out of state school to play against a Kentucky school and hold those schools to the same standards expected of Kentucky opponents.

ARTICLE VIII -- CONTESTS

Section 1. With Non-Member Kentucky Schools

Any member school which engages in an athletic contest with a nonmember Kentucky school eligible for membership in the Association may be suspended for a period to be determined by the Board of Control.

Q/A 1 -- May a member school of the Association engage in an athletic contest with a nonmember Kentucky school? No, not if the other school is eligible for membership.

Q/A 2 -- May a school team play against an alumni or independent team during a

regular season in the sport? Yes, as the other team is not eligible for membership in the Association. However, the game played with such a team must be counted against the game limit allowed each member school.

Section 2. With Schools in Other States

Any member school engaging in a contest with a school in another state shall play under the rules of the KHSAA and shall require its opponents to play under the rules of its own state association and belong to the applicable association in that state.

Rationale - Restrictions on playing schools outside the state should be the same as those in-state should schools choose to displace Kentucky opponents with out of state teams. In this manner, a level playing field is more assured.

Proposal V

Principal Joe Burks of Male proposes the following amendment to the bylaws of the Kentucky High School Athletic Association - An amendment to allow for tournament counting to be the same in soccer as in other KHSAA offerings.

Bylaw 25, Limitation of Seasons

6. Soccer

(4) A season will consist of a minimum of six (6) games and a maximum of seventeen (17) games including invitational tournaments. Each game played, irrespective of contest format; In any two (2) invitational or other type tournaments, the games played by a member school shall count as only one game against the limit of games.

Rationale - To extend the tournament counting exemption to soccer schools to allow for the playing of a full schedule in an already short season.

Tournament Guidelines For KAPOS '95



Participating cheerleader and cheerleading coaches registration: all cheerleading squads and/or coaches are asked to stop by the Kentucky Association of Pep Organization Sponsors table to:

1. Register your squad.
2. Pick up important information and materials for your squad.

Along with a KAPOS Board member, there will be high school cheerleaders to assist you. They can be identified by their hostess armbands. Feel free to ask them for help, and in turn, they may seek you and your cheerleaders to be interviewed by one of the radio commentators. In order to make their task easier, we are asking that you register your seat, row and section number. A possible radio interview is often missed because the guides could not locate the desired person in time for the interview.

Hospitality Room: We remind all cheerleaders and coaches that you are cordially invited to have refreshments, socialize with friends, exchange ideas and perhaps get help with your problems at our hospitality room.

Attention Principals: If your team will be participating in the Sweet 16, included in the packet sent to you by the KHSAA will be a letter pertaining to your cheerleading squad. Be sure to look for this and relay all information to your cheerleading coach. We request your cheerleaders be chaperoned by a well-qualified, school-approved adult. Verification of this, along with your cheerleading coach's name, must be reported in the letter of confirmation which you will receive. This letter must be in the hands of the KAPOS officer prior to the time your cheerleaders take the floor.

Important: Please be sure your school is a paid member of KAPOS or pays the fee before their first game in order for your squad to compete for the cheerleading awards in the State Tournament. The winners will be determined by use of a KAPOS Judging Sheet -- a copy appears in the KAPOS Handbook.

Awarding Trophies

KAPOS is pleased to honor outstanding cheerleading squads with recognition they so well deserve. All cheerleader

awards will be presented between games on Friday night of the State Tournament. The awards are as follows:

The winning cheerleading squad in the Boys' Sweet 16 will receive the Ted Sanford Trophy; the Girls' Sweet 16 winner will receive the Tom Mills Award. The runner-up, third- and fourth-place squads will receive trophies. In addition, the Special K-Pep Award will be presented. All tournament cheerleading squads and their coaches are asked to be located close to the playing floor so they can easily come on the floor should they win an award.

Sportsmanship Month

While every month should be Good Sportsmanship Month, KAPOS has always tried to put special emphasis on being a good sport at tournament time. Being a good sport is part of being a good citizen. We don't believe good citizens need to be reminded to exemplify good sportsmanship. However, it is especially fitting at tournament time to remind all citizens that it is a privilege to be able to attend the tournament and that each individual can contribute to the success of the tournament if he will abide by the KAPOS Sportsmanship Creed proclaimed by Governor Brereton Jones. The Governor's proclamation is on display at the KAPOS table. Remember, Be A Sport!

State-At-Large Champions

Recognition is given annually to the cheerleading squads other than those 16 fortunate enough to participate with their teams in the State Tournament. The winner will receive the Jane Meyer Trophy, while the runner-up will receive the KAPOS President's Trophy. Other trophies will be presented for the third-through 10th-place squads.

Beginning at the district level, all squads that are KAPOS members are eligible to be judged for the honor of representing their district in the KAPOS Region-At-Large cheerleading competition. The winner and runner-up of each district will progress to the region. In turn, the girls' varsity winner and runner-up and the boys' varsity winner and runner-up in the Traditional routine and the winner of the 2½ minute routine from each region is allowed to compete for the State-At-Large Cheerleading Championship.

Judging for the Boys' State-At-Large winners will take place at 8:30 a.m., Saturday, March 18, at Memorial Coliseum in Lexington. Judging for the Girls' State-At-Large winners will take place at 8:30

a.m., Saturday, March 25, at Memorial Coliseum. The public is invited to these outstanding events. The admission charge of \$4 will go toward the expenses of the KAPOS scholarship award -- details are supplied below.

At the conclusion of the judging, trophies will be awarded to the top squads in addition to several special awards.

Notes To Administrators

Many of you have responded to our SOS in releasing teaching personnel to assist with the many tasks necessary to keep this organization functioning effectively.

Again, we need judges and personnel help at the tournament. This involves at least 12-15 people. It is also back-breaking, tiresome work. However, we have many dedicated persons who have indicated a willingness to help share these duties provided they get a release from their administrators. Therefore, the KAPOS Board is seeking your understanding and cooperation should you be asked to release a teacher from his or her duties to help carry on the work KAPOS is doing to make cheerleading a worthwhile educational experience in the state of Kentucky.

Stella S. Gilb Scholarship

KAPOS is happy to annually award the Stella S. Gilb Scholarship to outstanding cheerleaders from Kentucky. In 1994, KAPOS awarded 10, \$500 scholarships to well-deserving cheerleaders. One of your cheerleaders may be a potential scholarship winner, so get your applications in early. Applications must be turned in no later than April 30. Contact a KAPOS Board member or officer for application forms or pick them up at the State Tournament KAPOS table.

KAPOS Services

- Maintains an affiliation with the KHSAA in order that we may help them and they may assist us in any way possible to promote good sportsmanship in the state of Kentucky.

- Maintains continual communication with cheerleading coaches in the state to ascertain their needs, problems, suggestions and criticism.

- Holds judging clinics to promote better understanding between cheerleading coaches and judges and to encourage consistency in interpretation of KAPOS rules and recommendations.

- Sponsors awards to outstanding



cheerleading squads at the district, regional and state levels.

• Sponsors Sportsmanship Month during March.

• Serves as host of the KAPOs table and the KAPOs Hospitality Room at the Girls' and Boys' Sweet 16s.

• Sponsors the Stella S. Gilb Scholarship, an educational scholarship awarded each year to outstanding and deserving cheerleaders in Kentucky.

• Presents the "Cheerleading Coach of the Year Award" for both girls' and boys' coaches.

• Presents the "Pat Dooley K-Pep Award" in each region and state tournament.

• Members serve as instructors and judges as requested by the various groups (KHSAA, YMCA, NCAA, schools, etc.).

• Sponsors the Kentucky Cheerleading Coaches Conference each July or August in Lexington.

Membership Requirements

He Did Build It And Now They're Coming

COACHES CARE AWARD

Alfred Redman, head basketball coach at Wyoming Indian High School in Ethete, Wyo., is receiving national recognition this month for utilizing his knowledge and resources to help Native American youngsters have a school of their own. Redman is being honored in coaching publications by Coaches Care, the public service program created by The Gatorade Company that pays tribute to high school coaches for providing young people with new opportunities and positive life experiences.

Redman, who was raised on the Wind River Reservation, knew all too well that school absenteeism and unemployment were common symptoms of an ineffective education system. So in the early 1970s, he joined tribal leaders and concerned parents to build a school that would breed hope as well as knowledge.

Redman's early years as an employee of the U.S. Government's Bureau of Indian Affairs gave him the knowledge to navigate bureaucratic red tape, which was instrumental in getting the Wyoming Indian High School built in 1972. Once the school opened, Redman followed his love for sports and joined the coaching staff as an assistant coach for football, basketball, volleyball and track.

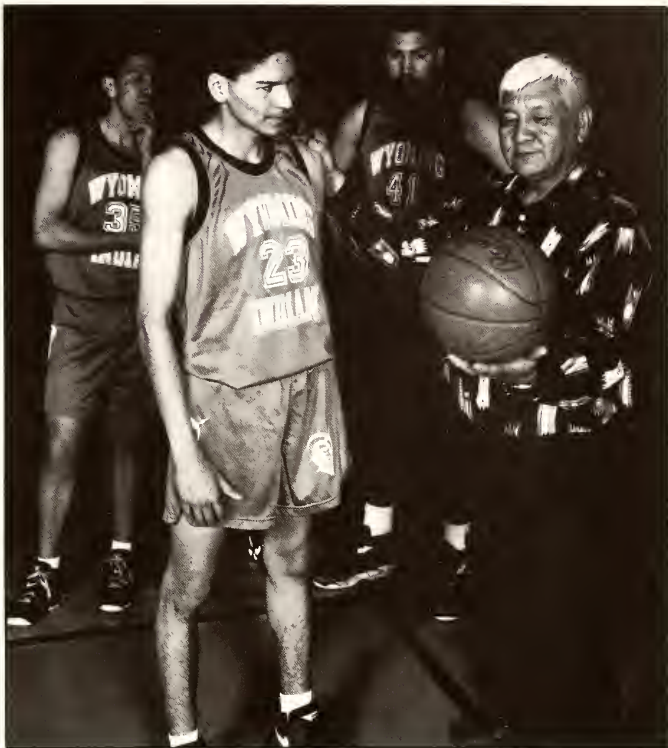
For eight years, the school was supported solely through the fund-raising efforts of the community, and was not an accredited school. Then in 1978, with intent to overcome the paucity of funding, athletic equipment and uniforms, Redman and other school board members developed a plan to join a local state supported elementary school. By 1981, the first public school district was started on the Wind River Reservation.

Redman was named head coach at the Wyoming Indian School in 1982 after receiving his teaching certificate from Fort Wright College in Spokane, Wash. Since then, he has gone on to win more than 200 games and five state titles.

"I decided to get my teaching certificate because I knew the kids deserved more than what I was giving them," said Redman, who currently teaches American government and current events. "I wanted to share my knowledge and experiences with kids in the classroom as well as on the court."

But Redman's true passion is for academics, not athletics.

"Al is very serious about scholastic excellence and helping kids go beyond

high school to carry out the leadership skills they learn from athletics," said Lonn Hoffman, principal at Wyoming Indian High School. "He lives and breathes for the students, encouraging them to do better for themselves and be proud of who they are in society."

Many of Redman's athletes live on their own or in extended families, so he checks on them to make sure they attend school, and keeps them busy during the summer. He and his staff volunteer their time at summer camps and coordinate fund-raisers so the kids can attend.

"Al has a reputation of going well beyond what you'd think most people would do for kids, even if they see just a little light, a little glimmer of hope," said Hoffman.

"With so many distractions in society today, young people need coaches like Alfred Redman to steer them in the

right direction," said Patti Jo Sinopoli, group manager of public relations at The Gatorade Company. "And we're proud to share his story with others across the country."

Since 1990, 522 coaches nationwide have been named to the Coaches Care Honor Roll. Redman is one of 21 coaches who have been featured in full-page advertisements that appear in coaching and athletic publications such as *Scholastic Coach*, *Athletic Business* and *Training & Conditioning* magazines.

Working For You

In Louisville during a January Board of Control meeting in 1992, I asked the Board to allow an increase of \$5 in official's annual registration fee. I requested this based on the provision that those additional monies be placed in an officials' trust fund and that these monies would only be used for officials' programs and activities.

It is intended to be earmarked for programs that would recognize the accomplishments and contributions that officials in each of our sports have made.

Recognition for a job well done is the cornerstone to an outstanding officials program. It enhances recruitment as well as the retention goals that we have. Recognition will motivate individuals to train themselves to be their best and all of this will, in the final analysis, help our young high school athletes as they compete.

My personal feeling is that what we do in this area is limited only by our imagination. I look forward to input from you as we dream and plan for future programs and ideas recognizing your commitment to our student-athletes.

Some of the things we have done include:

- issued over 200 personalized handbags to officials working our championship events;
- issued over 300 personalized certificates to championship officials;

• sponsored a free awards banquet in March;

• presented mantel clocks to each sport's most outstanding official at the banquet;

• will issue watches to outstanding sport's officials nominees;

• issuing KHSAA championship Fox 40 whistles to officials working championship contests;

• paid additional expert observers of officials at various events;

• videotaped and critiqued championship official's performances.

I am hopeful these things will motivate you to aspire to a level that will gain you your due recognition for all your hard work and dedication.

Remember, our (your and mine) imagination is our only limitation.

This past January, we approached the Board of Control to aid us in our officials recruiting and retention efforts. We asked that registration fees for full-time college students be decreased to \$15 for the first sport and \$10 for each additional sport.

We also asked that registration fees for officials serving the KHSAA for 25 years or longer be waived. The Board unanimously approved our recommendation. This will begin with the 1995-96 registration period.

NFICA/NFIOA Annual Meeting

Our own Lexington, Ky., will be the site of the annual NFICA/NFIOA meeting in 1996. It's scheduled June 21-25, 1996 at the Hyatt Regency adjacent to Rupp Arena. The national meeting is for coaches and officials of all sports and will be held the same weekend as the Kentucky-Tennessee All-Star football game.

Many of our officials' organizations have numerous required meetings preparing for the season. To encourage attendance by our host state and exemplify the hospitality our state is noted for, I suggest a consideration should be given those officials who attend the national conference. Perhaps credit for several meetings could be awarded. All organizations should give this idea serious consideration.

The 1995 meeting this summer will be held in Washington, D.C.

Technical Fouls

During observations, I have seen some confusion on administration of technical fouls. Many times, officials make moves in the direction of the wrong basket to shoot the free throws. Heading to

Quarterback Spike Among Rules Changes

KANSAS CITY -- Beginning with the 1995 high school football season, quarterbacks will be able to intentionally throw the ball forward to the ground to conserve time late in the game, as long as it is thrown immediately after receiving a direct hand-to-hand snap.

This rule change, which has been in effect at the college and professional levels for several years, was one of 16 passed by the National Federation Football Rules Committee at its Jan. 7-9 meeting in Albuquerque, N.M.

"Since quarterbacks will be able to spike the ball legally late in games to conserve time, it takes pressure off the officials to make a difficult judgement call when quarterbacks are trying to legally stop the clock," Dick Schindler, assistant director of the National Federation and editor of the high school football rules, said. "This has proved to be a very positive rule at other levels, and, with this procedure, it will make it an easier call for officials. A team is simply using a down to stop the clock. This is the rule change that should be the most noticeable at games next fall."

The committee, which is composed of one representative of each state high school association that uses National Federation playing rules, continued its emphasis on sportsmanship by strengthening its position against unsportsmanlike behavior.

Beginning with the 1995 season, the second unsportsmanlike foul by a player or nonplayer will result in disqualification from the contest. The rules previously covered penalties for unsportsmanlike

conduct, but there were no limits on the number of these penalties in a game.

"We had a similar disqualification rule for coaches, but we had no limits for players and nonplayers," Schindler said. "This change now penalizes everyone equally and ties this rule all together."

Kaye Pearce, executive director of the Kansas State High School Activities Association and in his first year as chairman of the National Federation Football Rules Committee, believes the stricter sportsmanship requirement was the most significant change this year.

"We believe that high school activities must promote sportsmanship, ethics and citizenship, and this additional penalty was put in place to help ensure proper behavior in high school football," Pearce said. "All in all, the rules committee didn't make any major changes because it believes the game is in good shape."

In other changes, the committee formulated a definition of fighting and provided a penalty of 15 yards and disqualification. Schindler said although aspects of fighting previously were included under illegal contact, an actual definition of fighting was absent from the book. He said a definition was needed to be able to enforce rules which penalize fighting.

The 1995 rules book will define fighting as "any attempt by a player or nonplayer to strike or engage an opponent in a combative manner unrelated to football. Such acts include but are not limited to: attempts to strike an opponent(s) with the arm(s), hand(s), leg(s) or foot (feet), whether or not there is contact."

The committee approved one signifi-

cant equipment change that will occur five years from now. Beginning with the 1999 season, football jerseys must be long enough to reach the top of the pants and must be tucked in if longer. Cut-off jerseys will not be allowed after the 1998 season.

Following is a summary of other revisions to high school football rules approved by the Football Rules Committee:

- The home team shall provide at least one legal ball. Previously, this was not mandated.

- On the player's uniform, each number may have a single, solid colored border, not to exceed one-half inch in width. This change will allow for the popular, fashionable shaded numbers, i.e. 49ers.

- Jewelry may not be worn during play.

- Blocking below the waist and/or clipping in the free-blocking zone is not to continue after the ball has left the zone.

- A new choice will be allowed to snap or free kick following a fair catch or awarded catch if a dead ball foul occurs before the play or an inadvertent whistle sounds and a replay results.

- Touching a forward pass by an ineligible behind the line will be illegal touching and flagged where the touching occurs and penalized as a loose ball foul.

Points of emphasis identified by the committee this year are roughing the kicker/holder/passers, taunting or baiting, and shifts/false starts.

1995 Wrestling Rules Interpretations



SITUATION #1: At the start of the third period, Wrestler A is up and Wrestler B is down. A applies an illegal hold and B is injured. During the recovery time the coach of Wrestler A says his wrestler should have started down for the third period. We now have bad time and, after two minutes recovery time, Wrestler B is unable to continue wrestling.

RULING: Wrestler A is the winner by default because all points earned during the third period are cancelled because of bad time. The only exception to this would be acts of flagrant misconduct. They are never overlooked regardless of the situation surrounding a correctable error. (6-6-2)

SITUATION #2: In an overtime match both wrestlers are warned for stalling after 45 seconds of competition, does the match, at this point, go into the tiebreaker or do we continue with the remainder of the overtime?

RULING: The overtime would be continued when both wrestlers are warned for stalling. The only time you discontinue the overtime period and go directly to the tiebreaker is when both wrestlers are penalized an equal number of points. (6-7-1)

SITUATION #3: With wrestlers in the neutral position, one wrestler false starts and applies a single leg on his opponent. The action is such that the wrestler suffered a leg injury that prevents him from continuing. What is the proper penalty?

RULING: There could be several incidents that occur in a legal maneuver where a wrestler might become injured and not be able to continue competition. As long as the referee feels that it is strictly a technical violation and no unnecessary roughness or unsportsmanlike conduct was involved then there would be no additional penalty beyond the technical violation. If the injured contestant was unable to continue after two minutes of injury time then he would lose the match by default. (8-2-2)

SITUATION #4: At the conclusion of the 119-pound match the 126-pound contestants report to the scorer's table. The individual that reports first still has his warm-ups on. Is this permissible?

RULING: The rule states that, in dual meet competition, the wrestler must be ready to go to the scorer's table immediately when called by the referee. This implies that the individual be ready to wrestle when he reports to the scorer's table. Therefore, the warm-ups must be off and, following reporting to the table, the wrestlers need to proceed directly to the center of the mat for the start of the match. There should be no delay from

the time the wrestlers report until they go to the center of the mat for competition. (6-2-2)

SITUATION #5: When a wrestler is injured and bleeding by an illegal hold, unnecessary roughness or unsportsmanlike conduct during the match, you are required to start the two minute recovery time. What is the proper procedure for the referee to follow at the conclusion of the two minute recovery time if the wrestler is still bleeding?

RULING: At that point, the referee needs to ask the injured contestant if he can continue once the bleeding is stopped. If the wrestler says no then the match is over and the injured contestant would win by default. If he says yes then the referee would give more time in order to stop the bleeding. (8-2-2 & 7)

SITUATION #6: Wrestler A is attempting to turn Wrestler B but has not yet met near fall criteria. While Wrestler A is turning Wrestler B, Wrestler B cries out in pain and the referee stops the match. Immediately following the referee stopping the match, Wrestler B indicates to the referee that he has been bitten on his right side. The referee thought that biting might have occurred but he did not actually see Wrestler A bite Wrestler B.

RULING: The general guidelines for officials to follow is, if in your opinion, a wrestler bites his opponent this will be deemed as intentional biting and will be called as flagrant misconduct. When the referee makes this call it must be an occurrence that came to his immediate attention. As an example, something that occurred in a previous period would not be given consideration (7-4-3)

SITUATION #7: At the conclusion of the 142-pound match, the 151-pound contestant from School A reports to the scorer's table and also the 160-pound competitor from School B reports to the table. The reason for the 160-pound contestant from School B reporting is that his school has no 151-pound contestant and he has simply come out early. The referee, after reviewing the situation, grants a forfeit to the 151-pound contestant from School A because there is no one in his weight class to compete against. He also rules that the 160-pound competitor, even though he reported early, is eligible to compete for the next match.

RULING: The rule does state that once either contestant is sent to the scorer's table they may not be withdrawn without being disqualified from the match. The rule also gives the referee the ability to correct errors that occur without penalizing either contestant. The reporting of the 160-pound contestant was simply an er-

ror and he will be able to compete for the next match. (6-2-2)

SITUATION #8: In dual meet competition both coaches have weighed in two contestants for the 275-pound match. For that particular match School A is required to send their wrestler to the scorer's table first. However, following the previous match, School B sends one of its contestants to the scorer's table prior to the coach of School A sending his wrestler. As soon as the coach from School A sends his wrestler to the scorer's table the coach of School B withdraws his first wrestler and replaces him with another contestant. Is this permissible?

RULING: Even though in this situation the wrestler from School A was required to go to the scorer's table first, if the individual from School B goes to the scorer's table first, he cannot be replaced. Once either contestant has reported to the scorer's table he cannot be withdrawn without forfeiting the match. Once you send your wrestler he must remain there and you no longer have a choice. (6-2-2)

SITUATION #9: After criteria has been met for a period of 2 seconds the defensive wrestler is able to stop the count but the offensive wrestler still maintains the hold. During this period of time the defensive wrestler cries out that he is injured. How many back points do you award him?

RULING: Even though the referee is not counting at the time, Rule 5-2-4g would still be in effect. When the defensive wrestler indicates he is injured, after near fall criteria has been met, the match will be stopped and a three-point near fall shall be awarded to his opponent. (5-2-4g)

SITUATION #10: The 275-pound contestant from School B steps onto the scales and the referee, who is conducting the weigh-in, asks for his letter from the state association office about the length of the hair. The wrestler's hair does exceed that allowed by rule and the referee is requesting the authorization from the state association office.

RULING: The coach speaks up for the wrestler in this situation indicating to the referee that having hair longer than allowed by rule no longer needs approval from the state association office as long as it is properly covered during the wrestling contest. The coach should then display to the referee what headgear will be used and how the hair rule will be satisfied when the contestant is on the mat. (4-2-1)

That way, when the administering official turns from the table to come back to the floor, he/she can move toward the off official and to the proper free throw lane in a timely and direct manner.

This will hopefully avoid a look of lost concentration or being emotionally out of control.
